PROCUREMENT FOR THE RENTAL OF EQUIPMENT AND CLEARING OF THE BANGKO SENTRAL NG PILIPINAS (BSP) PROJECT

RESOLUTION NO. BG-2023-048 (FAILURE OF BIDDING)

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through its 2023 Corporate Operating Budget (COB), has bid out the Procurement for the Rental of Equipment and Clearing of the Bangko Sentral ng Pilipinas (BSP) Project with an Approved Budget for the Contract (ABC) in the amount of Pesos: FOUR MILLION FOUR HUNDRED THIRTY-ONE THOUSAND NINE HUNDRED NINETY and 00/100 (Php4,431,990.00), inclusive of VAT and all other applicable government taxes, fees, and charges.

WHEREAS, the Bids and Awards Committee for Goods (BAC-G) advertised/posted the Invitation to Bid, including the bidding documents on 10 November 2023 in the following platforms:

- DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G has conducted a Pre-bid Conference on 17 November 2023, which was attended by the 3 Sides Builders;

WHEREAS, BAC-G issued Bid Bulletin No. BAC-G-2023-01 dated 23 November 2023 clarifying queries raised by the prospective bidder during the Pre-bid Conference and via email;

WHEREAS, no bid was received upon the lapse of the deadline for submission of bids set on 01 December 2023 9:00AM. Thus, BAC-G declared a failure of bidding for the Procurement for the Rental of Equipment and Clearing of the Bangko Sentral ng Pilipinas (BSP) Project pursuant to Section 35.1 of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) No. 9184, to wit:

"35. 1. The BAC shall declare the bidding a failure when:

a) No bids received;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**, to recommend the following:

- To declare a Failure of Bidding for the Procurement for the Rental of Equipment and Clearing of the Bangko Sentral ng Pilipinas (BSP) Project in accordance with Section 35.1 of the 2016 RIRR of RA 9184; and
- To direct the Engineering and Social Services Department (ESSD), as the end-user, to conduct a
 mandatory review and evaluation of the terms, conditions, and specifications of the bidding
 documents, including the cost estimates, and other requirements relative to this procurement,
 pursuant to Section 35.2 of the 2016 RIRR of RA 9184.
