RESOLUTION NO. BG-2023-052 (FAILURE OF BIDDING)

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through its 2023 Corporate Operating Budget (COB), has bid out the Procurement of BCDA Global Navigation Satellite System (GNSS) Base/Rover Package with Complete GNSS Terrestrial Bundle Software with an Approved Budget for the Contract (ABC) of FIVE MILLION NINE HUNDRED THOUSAND PESOS and 00/100 (Php5,900,000.00), inclusive of VAT and all other applicable government taxes, fees, and charges.

WHEREAS, the Bids and Awards Committee for Goods (BAC-G) advertised/posted the Invitation to Bid, including the bidding document on 10 November 2023 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G has conducted a Pre-bid Conference on 28 November 2023, which was attended by the following prospective bidders:

- a. Bay Core Precision Philippines, Corp.
- b. RASA Surveying

WHEREAS, BAC-G issued Bid Bulletin No. BAC-G-2023-01 dated 04 December 2023 clarifying queries raised by the prospective bidders during the pre-bid conference and via email;

WHEREAS, in response to said advertisements, one (1) bidder, Bay Core Precision Philippines, Corp. submitted their bids before the deadline of submission on 11 December 2023 (Monday) at 9:00AM at the BCDA Corporate Center, Bonifacio Global City, Taguig City.

WHEREAS, during the Opening of Bids on 11 December 2023 at 10:00 AM, BAC-G opened the bid submission of Bay Core Precision Philippines and noted that Bay Core Precision Philippines is NON-COMPLIANT due to the following:

- 1. Submission of Negative Net Financial Contracting Capacity (NFCC)
- 2. Non submission of Committed Line of Credit

WHEREAS, the BAC-G declared a failure of bidding for the Procurement of BCDA Global Navigation Satellite System (GNSS) Base/Rover Package with Complete GNSS Terrestrial Bundle Software pursuant to Section 35.1 of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184, to wit:

c) All bids <u>fail to comply with all the bid requirements</u> or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation; xxx"

- To declare a Failure of Bidding for the Procurement of BCDA Global Navigation Satellite System (GNSS) Base/Rover Package with Complete GNSS Terrestrial Bundle Software in accordance with Section 35.1 of the 2016 Revised Implementing Rules and Regulations (RIRR) of R.A. No. 9184; and
- To direct the end-user, Land and Assets Development Department (LADD) to conduct a mandatory review and evaluation of the terms, conditions, and specifications of the Bidding Documents, including the cost estimates, and other requirements relative to this procurement, pursuant to Section 35.2 of the 2016 RIRR of RA 9184.
