**PROCUREMENT OF EVENT MANAGEMENT SERVICES FOR THE
CONDUCT OF THE BCDA STAKEHOLDERS' APPRECIATION NIGHT**

**RESOLUTION NO. BG-2023-053
(FAILURE OF BIDDING)**

WHEREAS, the **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)**, through its 2023 Corporate Operating Budget (COB), has bid out the Procurement of Event Management Services for the Conduct of the BCDA Stakeholders' Appreciation Night with an Approved Budget for the Contract (ABC) of **FIVE MILLION PESOS (Php5,000,000.00)**, inclusive of VAT and all other applicable government taxes, fees, and charges.

WHEREAS, the Bids and Awards Committee for Goods (BAC-G) advertised/posted the Invitation to Bid, including the bidding documents on 16 November 2023 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G has conducted a Pre-bid Conference on 28 November 2023, which was attended by the following prospective bidders:

- a. Masaya Studio
- b. BusinessWorld Publishing Corp.
- c. Infoshare Management Systems
- d. ODV Creative Media, Inc.,

WHEREAS, BAC-G issued Bid Bulletin No. BAC-G-2023-01 dated 04 December 2023, clarifying queries raised by the prospective bidders during the Pre-bid Conference and via email;

WHEREAS, in response to said advertisement, one (1) bidder, BusinessWorld Publishing, Corp., submitted its bid before the deadline of submission on 15 December 2023 (Monday) at 9:00AM at the BCDA Corporate Center, Bonifacio Global City, Taguig City.

WHEREAS, during the Opening of Bids on 15 December 2023 at 10:00 AM, BAC-G opened the bid from the above-mentioned bidder, and noted that BusinessWorld Publishing, Corp. is **NON-COMPLIANT** due to the non-submission of the Price Schedule(s), Tab J of the Bidding Documents;

WHEREAS, BAC-G declared a failure of bidding for the **Procurement of Event Management Services for the Conduct of the BCDA Stakeholders' Appreciation Night** pursuant to Section 35.1 of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184, to wit:

"35.1 The BAC shall declare the bidding a failure when:

- c) All bids **fail to comply with all the bid requirements** or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation;
xxx"*

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**, to recommend the following:

1. To declare a Failure of Bidding for the **Procurement of Event Management Services for the Conduct of the BCDA Stakeholders' Appreciation Night** in accordance with Section 35.1 of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA). No. 9184 ; and
2. To direct the end-user unit, the Investment Promotions and Marketing Department (IPMD), to conduct a mandatory review and evaluation of the terms, conditions, and specifications of the bidding documents, including the cost estimates and other requirements relative to this procurement, pursuant to Section 35.2 of the 2016 RIRR of RA 9184.
