WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through the 2023 General Appropriations Act (GAA), has bid out the Procurement of the Operation and Maintenance of the New Clark City Sports Facilities: Lease of Multi-Purpose Tent System for the Athlete's Village in the National Government Administrative Center (NGAC) for the Hosting of the Asian Age Group Championships with an Approved Budget for the Contract (ABC) of SEVEN MILLION FIVE HUNDRED THOUSAND PESOS (Php7,500,000.00), inclusive of VAT and all other applicable government taxes, fees, and charges.

WHEREAS, the Bids and Awards Committee for Goods (BAC-G) advertised/posted the Invitation to Bid, including the bidding documents on 22 November 2023 in the following platforms:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G conducted a Pre-bid Conference on 04 December 2023, which was attended by a single prospective bidder, STAGE CRAFT INTERNATIONAL, INC.;

WHEREAS, BAC-G issued Bid Bulletin No. 1 dated 12 December 2023 concerning the Change of Schedule, specifically the deadline for the Submission of Bid Documents and Opening of Bids;

WHEREAS, in response to said advertisement, STAGE CRAFT INTERNATIONAL, INC., submitted its bid proposal before the deadline, at 9:00 AM on 19 December 2023;

WHEREAS, during the Opening of Eligibility and Technical Documents on 19 December 2023 at 10:00 AM, BAC-G noted the following:

WHEREAS, BAC-G deliberated on the results of the post-qualification and found that STAGE CRAFT INTERNATIONAL, INC. as legally, technically, and financially capable to undertake the project;

NOW, THEREFORE, We, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- To declare and recommend the award of contract to STAGE CRAFT INTERNATIONAL, INC., as the Single Calculated and Responsive Bidder (SCRB) for the Procurement of the Operation and Maintenance of the New Clark City Sports Facilities: Lease of Multi-Purpose Tent System for the Athlete's Village in the National Government Administrative Center (NGAC) for the Hosting of the Asian Age Group Championships in the amount of Seven Million Four Hundred Sixty Thousand Pesos and 00/100 Only (Php7,460,000.00), inclusive of VAT and all applicable taxes and fees.;
- To direct the Information and Communication Technology Department (ICTD) and Investment Promotions and Marketing Department (IPMD), as the end-user units, to submit to BAC-G the Notice of Award, Notice to Proceed, and the duly executed agreement/contract during the prescribed period.
