WHEREAS, BAC-G issued Bid Bulletin No. 1 dated 07 December 2023 clarifying queries raised by the prospective bidders during the pre-bid conference and subsequently, via e-mail;

WHEREAS, in response to said advertisements, **BGC PHILBUILDER**, **INC.**, is the sole bidder that submitted bid proposal before the deadline at 9:00 AM on 14 December 2023;

WHEREAS, during the Opening of eligibility and technical documents on 14 December 2023 at 10:00 AM, BAC-G noted the following:

WHEREAS, on 14 December 2023 to 18 December 2023, the BAC-G conducted a detailed bid evaluation of the bidding documents of the sole bidder and noted the following findings:

- a. The bid proposal submitted by the sole bidder was found to be compliant with the legal and technical requirements;
- b. Based on the submitted financial bid, BAC-G declared BGC PHILBUILDER, INC. as the Single Calculated Bidder (SCB) for the Procurement of the Operations and Maintenance of NCC Access Roads (Estate Management).

WHEREAS, the BAC-G recommended that BGC PHILBUILDER, INC. undergo a post qualification on **20-26 December 2023**, pursuant to Section 34 of Rule X – Post-Qualification of the 2016 Revised Implementing Rules and Regulations (RIRR) of the Republic Act No. 9184;

WHEREAS, BAC-G deliberated on the results of the post-qualification and found that BGC PHILBUILDER, INC. is legally, technically, and financially capable to undertake the project;
