QUERY	CLARIFICATION
Is it still required to repurchase the bidding documents as there was a similar bidding for this project in 2023?	YES, prospective bidders are required to pay the fee provided in the Invitation to Bid. This bidding requirement is in conformity with Section 17.4 and Appendix 8 (Guidelines on the Sale of Bidding Documents) of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) No. 9184 that the Bidders may be asked to pay a fee to recover the cost for the preparation and development of the Bidding Documents.
