RASA SURVEYING AND REALTY, a sole proprietorship duly organized and existing under the laws of the Republic of the Philippines, with office address at No. 9 Anlacan Compound, Philand Subdivision, Tandang Sora, Quezon City, represented herein by its General Manager/Owner, ENGR. RAYMUND ARNOLD S. ALBERTO, as its authorized representative, hereinafter referred to as the "Consultant"

BCDA is desirous that the Consultant execute the Procurement of Consulting Services for the Conduct of Land Survey for various BCDA Properties (hereinafter called the "Project") and the BCDA has accepted the bid for Four Million Pesos (Php 4,000,000.00) by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

- (g) Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/ statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
- (h) Eligibility requirements, documents and/or statements;
- (i) Performance Security;
- (j) Notice of Award of Contract and the Bidder's conforme thereto;
- (k) Other contract documents that may be required by existing laws and/or the Entity.
- In consideration of the full and satisfactory performance of the services rendered by the Consultant, BCDA shall pay the Consultant based on the schedule of payment as indicated in the Terms of Reference.
- 4. In consideration of the payments to be made by the BCDA to the Consultant as hereinafter mentioned, the Consultant hereby covenants with BCDA to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Contract in all respects.
