RESOLUTION NO. BG-2024-007

WHEREAS, the **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)**, through the 2023 General Appropriations Act (GAA), has bid out the **Procurement of the Operation and Maintenance of the New Clark City Sports Facilities: Lease of Timing and Scoring System and Services for the Aquatics Center in the National Government Administrative Center (NGAC) for the Hosting of the Asian Age Group Championships** with an Approved Budget for the Contract (ABC) of **FIVE MILLION PESOS (Php5,000,000.00)**, inclusive of VAT and all other applicable government taxes, fees, and charges.

WHEREAS, the Bids and Awards Committee for Goods (BAC-G) advertised/posted the Invitation to Bid, including the bidding documents on 13 January 2024 in the following platforms:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G conducted a Pre-bid Conference on 22 January 2024, which was attended by a single prospective bidder, **AMIGO ENTERTAINMENT TECHNOLOGIES INC.**;

WHEREAS, BAC-G issued Bid Bulletin No. 1 dated 29 January 2024 concerning the queries raised during the Pre-Bid Conference;

WHEREAS, in response to said advertisement, **AMIGO ENTERTAINMENT TECHNOLOGIES INC.** submitted its bid proposal before the deadline at 9:00 AM on 05 February 2024;

WHEREAS, during the Opening of Eligibility and Technical Documents on 05 February 2024 at 10:00 AM, BAC-G noted the following:

WHEREAS, on 06 February 2024, BAC-G conducted a detailed bid evaluation of the bidding documents of the sole bidder and found that the bid proposal submitted by **AMIGO ENTERTAINMENT TECHNOLOGIES INC.** to be compliant with the legal and technical requirements, and hence, declared **AMIGO ENTERTAINMENT TECHNOLOGIES INC.** as the Single Calculated Bidder (SCB) for the Procurement of the Operation and Maintenance of the New Clark City Sports Facilities: Lease of Timing and Scoring System and Services for the Aquatics Center in the National Government Administrative Center (NGAC) for the Hosting of the Asian Age Group Championships. WHEREAS, BAC-G deliberated on the results of the post-qualification dated 12 February 2024 and found that **AMIGO ENTERTAINMENT TECHNOLOGIES INC.** as legally, technically, and financially capable to undertake the project;

2. To direct the **Information and Communication Technology Department (ICTD) and Investment Promotions and Marketing Department (IPMD)**, as the end-user units, to submit to BAC-G the Notice of Award, Notice to Proceed, and the duly executed agreement/contract during the prescribed period.
