DELA FUENTE, duly authorized for this purpose as evidenced by Secretary's Certificate dated 09 November 2023 hereto attached as Annex "B" and made an integral part hereof and hereinafter called the "SUPPLIER".

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

    - iv. Supplemental or Bid Bulletins, if any
  - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid

Five Hundred Sixty Pesos and 00/100 Only (Php2,503,560.00), or such other sums as may be ascertained, CGS SOLID AIRCON AND REFRIGERATION. INC. agrees to supply, deliver and install Air-Conditioning Units for the National Academy of Sports (NAS) - Phase 2 in accordance with his/her/its Bid.
- The BASES CONVERSION AND DEVELOPMENT AUTHORITY agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


