

**Supply, Delivery and Installation of Gymnastics Equipment
for the National Academy of Sports (NAS) – Phase 2
at New Clark City**

CONTRACT AGREEMENT

THIS AGREEMENT made the ____ day of _____, 20__ between **BASES CONVERSION AND DEVELOPMENT AUTHORITY** with principal office at BCDA Corporate Center, 2nd Floor Bonifacio Technology Center, 31st corner 2nd Avenue, Bonifacio Global City, Taguig City, Metro Manila, Philippines represented herein by its President and Chief Executive Officer, **JOSHUA M. BINGCANG**, duly authorized for this purpose under BCDA Board Resolution No. 2023-04-049, as evidenced by Secretary's Certificate dated 20 July 2023 hereto attached as Annex "A" and made an integral part hereof and hereinafter called the "**ENTITY**" and **APACTIVEPRO TRADING** with principal office at 201 N Domingo Street, San Juan City, Metro Manila, Philippines, represented herein by its Authorized Representative, **JUSTINN VINCENT SZE**, duly authorized for this purpose as evidenced by Special Power of Attorney dated 08 November 2023 hereto attached as Annex "B" and made an integral part hereof and hereinafter called the "**SUPPLIER**" of the other part.

WHEREAS, the Entity invited Bids for certain goods and ancillary services particularly the **Supply, Delivery and Installation of Gymnastics Equipment for the National Academy of Sports (NAS) – Phase 2 at New Clark City** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Twenty Million Four Hundred Thirty-Three Thousand Pesos and 00/100 Only (Php20,433,000.00)** (hereinafter called "**the Contract Price**").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;

- d. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **Twenty Million Four Hundred Thirty-Three Thousand Pesos and 00/100 Only (Php20,433,000.00)**, or such other sums as may be ascertained, **APACTIVEPRO TRADING** agrees to supply, deliver and install **Gymnastics Equipment** for the National Academy of Sports (NAS) – Phase 2 in accordance with his/her/its Bid.
 4. The **BASES CONVERSION AND DEVELOPMENT AUTHORITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.

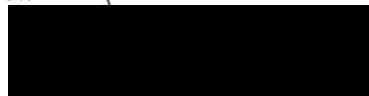

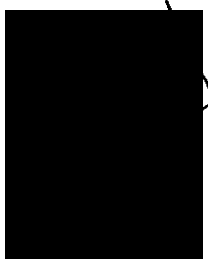
