BINGCANG**, who is duly authorized for this purpose as evidenced by a Secretary's Certificate dated 06 November 2023, a copy of which is hereto attached as **Annex "A"**, hereinafter referred to as **"BCDA"**;

NIPPON KOEI CO., LTD. AND PHILKOEI INTERNATIONAL, INC. JOINT VENTURE (JV), an entity duly organized and existing under the laws of the Republic of the Philippines, with office address at Units 3301 and 3302, 33rd Floor, Corporate Finance Plaza, Ruby St. Ortigas Center, Pasig City 1605, represented herein by its Authorized Representative, **MASASHI SADAIE**, who is duly authorized for this purpose as evidenced by a Power of Attorney dated 24 November 2023, a copy of which is hereto attached as **Annex** "B", hereinafter referred to as "**Consultant**".

Each individually referred to as "Party" and collectively as "Parties."

ANTECEDENTS:


On 25 October 2023, the BCDA Board of Directors approved the procurement of consulting services or technical expert who will prepare a detailed engineering design (DED) for the long-term or permanent solution for the Subic-Clark-Tarlac Expressway (SCTEX) Pasig Potrero Bridge through Emergency Procurement. The corresponding Approved Budget Contract (ABC) for this project is Php 122,810,057.88.

On 23 November 2023, the Strategic Projects Management Department (SPMD) formally requested the Bids and Awards Committee for Consulting Services (BAC-C) to facilitate the procurement of the services of a consultant who will prepare the detailed engineering design (DED) for the long-term solution for the Pasig Potrero Bridge at SCTEX through Negotiated Procurement under Emergency Cases in accordance with Section 53.2 of the 2016 Revised Implementing Rules and Regulations and Regulations (RIRR) of Republic Act (RA) No. 9184.

The Project qualifies for emergency procurement as the SCTEX Pasig Potrero Bridge, in its current condition, is highly susceptible to lateral forces, including seismic activities or earthquakes, due to the extensive quarrying activities along the Pasig Potrero River, thus, posing great danger and risks to the motorists and the public.

With the authority delegated by the Head of Procuring Entity, the BAC-C sent a request for Proposal (RFP) to Nippon Koei Co., Ltd. and Philkoei International, Inc., a consultant endorsed by the SPMD.





The BAC-C negotiated with Nippon Koei Co., Ltd. and Philkoei International, Inc.

After careful evaluation and thorough deliberation of the bid proposal submitted for the Project, the BAC-C recommended the award of contract to Nippon Koei Co., Ltd. and Philkoei International, Inc. in the amount of Php 121,838,000.00, inclusive of all applicable taxes and fees.

On 07 December 2023, the BCDA, through its Board of Directors, approved the recommendation of the BAC-C to award the contract to Nippon Koei Co., Ltd. and Philkoei International, Inc.

BCDA is desirous that the Consultant execute the CONTRACT FOR CONSULTING SERVICES FOR THE DETAILED ENGINEERING DESIGN (DED) OF THE LONG-TERM SOLUTION OF THE PASIG-POTRERO BRIDGE AT SCTEX (hereinafter called "the Consulting Services") and BCDA has accepted the bid for **Pesos: One Hundred Twenty-One Million Eight Hundred Thirty Eight Thousand and 00/100 (PhP 121,838,000.00)**, inclusive of all applicable taxes, fees and other charges, by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

ACCORDINGLY, the Parties agree as follows:

- 1. In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents shall be attached, deemed to form, and be read and construed as part of this Contract, to wit:
 - (a) Terms of Reference;
 - (b) Eligibility requirements, documents and/or statements;
 - (c) Performance Security;
 - (d) Notice of Award of Contract and the Consultant's conforme thereto;
 - (e) Other contract documents that may be required by existing laws and/or BCDA.
- In consideration of the payments to be made by BCDA to the Consultant as hereinafter mentioned, the Consultant hereby covenants with BCDA to execute and complete the Consulting Services and remedy the defects therein in conformity with the provisions of this Contract in all respects.
- 4. BCDA hereby covenants to pay the Consultant in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


