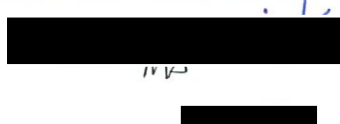

WHEREAS, the **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)**, through the 2023 General Appropriations Act (GAA), has bid out the **Procurement of the Operation and Maintenance of the NCC Sports Facilities: Supply, Delivery and Installation of Additional Sports Equipment and Facility Accessories, Retractable Seating System and Fabricated Items for the Aquatics Center in the National Government Administrative Center for the Hosting of the Asian Age Group Championships** with an Approved Budget for the Contract (ABC) of **SEVENTEEN MILLION SIX HUNDRED NINETY TWO THOUSAND PESOS (Php17,692,000.00)**, inclusive of VAT and all other applicable government taxes, fees, and charges, with the following lots:

WHEREAS, the Bids and Awards Committee for Goods (BAC-G) advertised/posted the Invitation to Bid, including the bidding documents on 22 November 2023 in the following platforms:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G conducted a Pre-bid Conference on 04 December 2023, which was attended by the prospective bidders namely, **STAGE CRAFT INTERNATIONAL, INC.** and **E-Sports**;

WHEREAS, BAC-G issued Bid Bulletin No. 3 dated 22 December 2023 for the Changes of Schedule, specifically the deadline for the Submission of Bid Documents and Opening of Bids;

WHEREAS, in response to said advertisement, two (2) bidders submitted their bids before the deadline, at 12:00 NN on 08 January 2024 for the following specific lot/s:

WHEREAS, from 08 to 15 January 2024, the BAC-G Technical Working Group (TWG) conducted a detailed bid evaluation of the bidding documents of the bidders, and observed that: The bid proposals submitted by **AMIGO ENTERTAINMENT TECHNOLOGIES INC.** and **STAGE CRAFT INTERNATIONAL, INC.** are compliant with the legal and technical requirements; and thus, recommended that **AMIGO ENTERTAINMENT TECHNOLOGIES INC.** be declared as the Single Calculated Bidder (SCB) for Lot 1 and **STAGE CRAFT INTERNATIONAL, INC.** as the Single Calculated Bidder (SCB) for Lots 2 and 3 for the Procurement of the Operation and Maintenance of the NCC Sports Facilities: Supply, Delivery and Installation of Additional Sports Equipment and Facility Accessories, Retractable Seating System and Fabricated Items for the Aquatics Center in the National Government Administrative Center for the Hosting of the Asian Age Group Championships. WHEREAS, BAC-G recommended that **AMIGO ENTERTAINMENT TECHNOLOGIES INC.** and **STAGE CRAFT INTERNATIONAL, INC.** undergo a post qualification evaluation pursuant to Section 34 of Rule X – Post-Qualification of the 2016 Revised Implementing Rules and Regulations (RIRR) of the Republic Act No. 9184;

WHEREAS, on 29 January 2024, the BAC-G TWG presented the results of the post-qualification and upon deliberation by BACG-G, **AMIGO ENTERTAINMENT TECHNOLOGIES INC.** and **STAGE CRAFT INTERNATIONAL, INC.** were found to be legally, technically, and financially capable to undertake the Project;

NOW, THEREFORE, We, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**:

To declare and recommend the award of contract to **AMIGO ENTERTAINMENT TECHNOLOGIES INC.** as the Single Calculated and Responsive Bidder (SCRB) for Lot 1 (Sports Equipment and Facility Accessories) for the Procurement of the Operation and Maintenance of the NCC Sports Facilities: Supply, Delivery and Installation of Additional Sports Equipment and Facility Accessories, Retractable Seating System and Fabricated Items for the Aquatics Center in the National Government Administrative Center for the Hosting of the Asian Age Group Championships in the amount of **One Million Eight Hundred Sixty Eight Thousand Seven Hundred Twenty Two Pesos and 11/100 Only (Php1,868,722.11)**, inclusive of VAT and all applicable taxes and fees.;

To declare and recommend the award of contract to **STAGE CRAFT INTERNATIONAL, INC.**, as the Single Calculated and Responsive Bidder (SCRB) for Lot 2 (Retractable Seating System) and Lot 3 (Fabricated Items) for the Procurement of the Operation and Maintenance of the NCC Sports Facilities: Supply, Delivery and Installation of Additional Sports Equipment and Facility Accessories, Retractable Seating System and Fabricated Items for the Aquatics Center in the National Government Administrative Center for the Hosting of the Asian Age Group Championships in the amount of **Nine Million Nine Hundred Sixty Thousand Pesos and 00/100 Only (Php9,960,000.00) for Lot 2, and Five Million Seven Hundred Forty Five Thousand and Four Hundred Pesos and 00/100 Only (Php5,745,400.00) for Lot 3, inclusive of VAT and all applicable taxes and fees; and,**
3. To direct the **Information and Communication Technology Department (ICTD) and Investment Promotions and Marketing Department (IPMD)**, as the end-user units to submit to BAC-G the Notice of Award, Notice to Proceed, and the duly executed agreement/contract with the prescribed period.
