## **RESOLUTION NO. BG-2023-057**

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through the CY 2023 Corporate Operating Budget (COB) and General Appropriation Act, has undertaken the Procurement of the Annual Subscription of the BCDA Email System with an Approved Budget for the Contract (ABC) of Three Million Five Hundred Forty-One Thousand and 00/100 (PhP3,541,000.00), inclusive of all applicable taxes and fees. - c. In a conspicuous place reserved for the purpose in the premises of BCDA.


WHEREAS, BAC-G conducted the Pre-bid Conference on 16 November 2023 which was attended by the following prospective bidders:


WHEREAS, in response to said advertisement, the following four (4) bidders submitted bid proposals before the deadline at 9:00 AM on 29 November 2023, namely:

WHEREAS, during the Opening of eligibility and technical documents on 29 November 2023 at 10:00 AM, BAC-G noted the following

WHEREAS, on 30 November 2023 to 06 December 2023, the BAC-G conducted a detailed bid evaluation of the bidding documents of the four (4) bidders and noted the following:

- a. The bid proposals submitted by the four (4) bidders were found to be compliant with the legal and technical requirements;
- b. Based on the submitted financial bids, BAC-G declared ePLDT Inc. as the Lowest Calculated Bidder (LCB) for both Lot 1 and Lot 2 for the Annual Subscription of the BCDA Email System.

The copy of the Detailed Evaluation Report is hereto attached as Annex B;

WHEREAS, the BAC-G recommended that e-PLDT Inc. undergo a post qualification within the period **08-14 December**, **2023**, pursuant to Section 34 of Rule X — Post-Qualification of the 2016 Revised Implementing Rules and Regulations (RIRR) of the Republic Act No. 9184;

WHEREAS, BAC-G deliberated on the results of the post-qualification and found that e-PLDT Inc. is legally, technically, and financially capable to undertake the project;
