PROCUREMENT OF ANNUAL MAINTENANCE OF HYBRID BACKUP SOLUTIONS

RESOLUTION NO. BG-2024-13

The **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)**, through the CY 2024 Corporate Operating Budget (COB), has undertaken the **Procurement of the Annual Maintenance of Hybrid Backup Solution** with an Approved Budget for the Contract (ABC) of **Two Million Two Hundred Thousand and 00/100 Pesos (PhP2,200,000.00)**, inclusive of VAT and all other applicable government taxes and fees;

WHEREAS, the Bids and Awards Committee for Goods (**BAC-G**) advertised/posted the Invitation to Bid including the bidding documents on 21 February 2024 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G conducted the Pre-bid Conference on 29 February 2024 which was attended by Sandz Solutions Philippines Inc., as the sole prospective bidder;

WHEREAS, in response to said advertisements, **Sandz Solutions Philippines Inc.** submitted its bid for the project before the deadline of submission on 12 March 2024 at 9:00 AM;

WHEREAS, on 20 March 2024, BAC-G conducted a detailed bid evaluation of the bid proposal of the sole bidder and found that its legal and technical documents are compliant with the requirements of R.A. No. 9184 and the Bid documents, and, declared **Sandz Solutions Philippines Inc.** as the Single Calculated Bidder (SCB). Moreover, its financial bid as calculated, as shown in the table below, is within the ABC:

WHEREAS, BAC-G recommended **Sandz Solutions Philippines Inc.** to undergo a post qualification from **22-26 March 2024**, pursuant to Section 34 of Rule X – Post-Qualification of the 2016 Revised Implementing Rules and Regulations (RIRR) of the Republic Act No. 9184;

WHEREAS, based on results of the post qualification, the BAC-G Technical Working Group (TWG) found that **Sandz Solutions Philippines Inc.** is responsive with the eligibility, technical, legal and financial requirements, per R.A. No. 9184 and the bidding documents;

WHEREAS, on 27 March 2024, BAC-G deliberated the results of the post qualification of **Sandz Solutions Philippines Inc.**, based on the TWG Report. BAC-G found that **Sandz Solutions Philippines Inc.** is legally, technically, and financially capable to undertake the project.

NOW, THEREFORE, We, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**:

1. To declare **Sandz Solutions Philippines Inc.**, as the Single Calculated and Responsive Bidder (SCRB) for the **Procurement of the Annual Maintenance of Hybrid Backup Solution**;
2. To award the contract to **Sandz Solutions Philippines Inc.**, in the amount of **Two Million One Hundred Sixty-Eight Thousand Nine Hundred Eighty-Eight Pesos and 00/100 (Php2,168,988.00)**, inclusive of VAT and all applicable taxes and fees;
3. To issue the corresponding Notice of Award (NOA) to **Sandz Solutions Philippines Inc.** (Copy Attached); and
4. To direct the Information and Communications Technology Department (ICTD), being the end-user unit, to submit to the BAC-G the duly confirmed Notice of Award, Notice to Proceed, and the duly executed agreement/contract during the prescribed period.
