The **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)**, through the CY 2024 General Appropriations Act, has undertaken the **Procurement of ICT Annual Maintenance Subscription with On-Site Engineers** with an Approved Budget for the Contract (ABC) of **Twenty One Million, Three Hundred Thousand Pesos and 00/100 (PhP21,300,000.00)**, inclusive of Value Added Tax (VAT) and all other applicable government taxes and fees;

WHEREAS, the Bids and Awards Committee for Goods (**BAC-G**) advertised/posted the Invitation to Bid including the bidding documents 14 March 2024 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G conducted a Pre-bid Conference on 21 March 2024 at 10:00 AM, which was attended by a lone prospective bidder, Trends & Technologies, Inc.;

WHEREAS, in response to the said advertisement, Trends & Technologies, Inc. submitted its bid before the deadline for the submission of bids on 05 April 2024 at 9:00 AM;

WHEREAS, during the Opening of Bids on 05 April 2024 at 10:00 AM, BAC-G opened the bidding documents of the sole bidder - Trends & Technologies, Inc., and noted that it passed the eligibility and technical proposal requirements;

WHEREAS, the financial proposal of Trends & Technologies, Inc. was opened and BAC-G noted the following:

WHEREAS, BAC-G deliberated on the results of the post-qualification and found that Trends & Technologies, Inc. is eligible, legally, technically, and financially capable to undertake the project;

NOW, THEREFORE, premises considered, We, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**, to recommend the following:

To declare Trends & Technologies, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the **Procurement of ICT Annual maintenance subscription with On-Site Engineers**, and to award the contract in the amount of **Twenty One Million Two Hundred Ninety Eight Thousand Nine Hundred Ninety-Nine Pesos and 82/100 (Php21,298,999.82)**, inclusive of VAT and all applicable taxes and fees.
2. To direct the Information and Communications Technology Department (ICTD), being the end-user unit, to submit to the BAC-G the duly conformed Notice of Award, Notice to Proceed, and the duly executed agreement/contract during the prescribed period.


