Q1.	Discount. Shall the computation (in words and figures) of the discount be included in the financial bid form?	In filling out the discount portion (Item d.) of the bid form, the bidders shall specify the discount offered by indicating the percentage or amount, and the method of application of the discount (i.e., whether the discount shall be applied proportionally across all pay items in the Bill of Quantities (BOQ) or only for specific pay items/scope).					
Q2.	Embankment. There is an item in the site development for the apartment, and inside the apartment, there is another embankment item. Please clarify.	Pay Item 104 (2)a.2 under the Site Development refers to the embankment for the areas outside the building footprint. On the other hand, Pay Item 804 (1)b under the 14-Door Apartment pertains to the embankment for the area within the building footprint.

Q3. Attendance to the Site Inspection.

Shall the attendance of Site Inspection be a requirement in the eligibility for this bidding project?

Participation in the Site Inspection is encouraged but not required. Likewise, a certificate of attendance is not a requirement under the Bidding Documents.

Q4. SLCC.

The SLCC requirement states that "This statement shall be supported by contracts, certificate of completion and owner's final acceptance, and CPES rating sheets, if applicable."

In the case of a project that is completed but not yet accepted, shall a Certificate of Completion be accepted? No. Section 23.4.2.5 of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) No. 9184 provides that:

"The SLCC shall be supported by an Owner's Certificate of Final Acceptance issued by the project owner other than the contractor or a final rating of at least Satisfactory in the Constructors Performance Evaluation System (CPES). In case of contracts with the private sector, an equivalent document shall be submitted".

Hence, participating bidders are advised to synchronize their timepieces with the said computer system clock.

Online Bid Submission is NOT allowed.

- 5. The bid should <u>not</u> be more than the Approved Budget for the Contract (ABC), otherwise, the bidder will be disqualified.
- 6. **Opening of Bids.** Bid Opening shall be on **01 July 2024, 10:00 AM** at the BCDA Office, BCDA Corporate Center, 2nd Floor Bonifacio Technology Center, 31st Street Corner 2nd Avenue, Crescent Parkwest, Bonifacio Global City, Taguig.
 - The BAC expects the bidders to exercise due diligence in going through the bidding documents to be able to prepare their bids intelligently.
- 7. The Bidders are requested to use tabs in compiling their bid documents for quick and easy identification and verification.
- 8. The computation of the Bid Security shall be based on the ABC. The bidders may submit a notarized Bid Securing Declaration in lieu of other forms of bid security. It is important to note, however, that although the Bid Securing Declaration does not require cash, its enforcement will include automatic blacklisting and payment of certain fines in the event that the bidder violates any of the conditions set forth in the bidding documents.
- 9. Visiting or calling (including sending text messages) the members of the BAC-I, the TWG, the Secretariat (except for administrative matters relating to the project), or anyone working in BCDA is prohibited and will not be entertained. All queries should be addressed to the BAC-I Chairperson and emailed or sent through written correspondence to the Secretariat until the deadline for requests for clarification.
