



Procurement of Appraisal Services Of Various BCDA Properties for 2024

BID BULLETIN NO. 2

This Bid Bulletin clarifies the queries raised during the Pre-bid Conference on 14 June 2024 at 01:00 PM and from various queries received through email from the prospective bidders, as well as other matters relative to the above Project.

A. Queries/Questions from the Prospective Bidders

	QUERY	CLARIFICATION
1.	Clarification on the requirement - PhilGEPS certificate, our PhilGEPS is ongoing renewal. Are there any documents we can provide?	No, the valid Philippine Government Electronic Procurement System (PhilGEPS) certificate must be submitted on or before the deadline of submission of bids.
2.	The schedule of requirements specifically on the mentioned appraisal reports shall include a prospective clear valuation projection. Does it mean we must provide the valuation report with a whole narrative report? Or just the value itself?	The valuation for 2025, 2026, and 2027 will suffice.
3.	Regarding the requirements checklist for Class A Documents and technical Documents for all ongoing contracts. Only a list of all ongoing projects are needed?	Yes, only a list of all ongoing projects. However, the bidder also has the option to submit additional supporting documents.
4.	Can 50% of ABC requirements be aggregated for the same project?	No. The requirement for Single Largest Completed Contract (SLCC) is one similar contract, not aggregate. The contract amount must be equivalent to at least 50% of the Approved Budget for the Contract.
5.	We are not accredited by the SEC or BSP. Is that your standard? Or is there an equivalent experience? To override the required government procurement that we should be accredited to BSP, Can we join even if we are not accredited by BSP or SEC.	Section VII. Technical Specifications, B - General Requirements states that: "The Appraisal Company/Firm must be included in the list of appraisal companies accepted by BSP, DOF and PSE". This means that the appraisal company may be accredited with either of the 3 agencies.
