

**CONTRACT AGREEMENT
FOR THE ICT ANNUAL MAINTENANCE SUBSCRIPTION WITH
ON-SITE ENGINEERS NEW CLARK CITY**

BASES CONVERSION AND DEVELOPMENT AUTHORITY (“BCDA”), a government instrumentality vested with corporate powers under Republic Act (RA) 7227 (Bases Conversion and Development Act of 1992), with offices at BCDA Corporate Center, 2nd Floor, Bonifacio Technology Center, 31st St., corner 2nd Avenue, Bonifacio Global City, Taguig, Metro Manila 1634, represented by its President and CEO, **JOSHUA M. BINGCANG**, duly authorized for this purpose provided in Section IV. 19, Page 11 of the BCDA’s Revised Manual of Approval dated 22 November 2017, a copy of which is hereto attached as Annex “A” and made an integral part hereof and hereinafter referred to as “**BCDA**”;

The **TRENDS AND TECHNOLOGIES, INC.**, with registered office at 8th Floor Trafalgar Plaza 105 H.V. Dela Costa St., Salcedo Village, Makati City, represented herein by its Account Manager, **DARWIN C. JACINTO**, who is duly authorized for this purpose evidenced by its Secretary Certificate dated 02 April 2024, a copy of which is hereto attached as Annex “B” and made an integral part hereof, hereinafter referred to as “**SUPPLIER**”.

WHEREAS, the BCDA invited Bids for certain goods and ancillary services, particularly ICT Annual Maintenance Subscription with On-Site Engineers New Clark City, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Twenty-One Million Two Hundred Ninety-Eight Thousand Nine Hundred Ninety-Nine Pesos and 82/100 (Php21,298,999.82) inclusive of VAT and all applicable taxes and fees (hereinafter called “the Contract Price”).

ACCORDINGLY, the Parties agree as follows:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as an integral part of this Agreement, *viz.*:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder’s bid, including the Eligibility requirements,

Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;


- iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of Twenty-One Million Two Hundred Ninety-Eight Thousand Nine Hundred Ninety-Nine Pesos and 82/100 (Php21,298,999.82) inclusive of VAT and all applicable taxes and fees or such other sums as may be ascertained, Trends and Technologies, Inc. agrees to Procurement of ICT Annual Maintenance Subscription with On-Site Engineers New Clark City in accordance with its Bid.
4. BCDA agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
