RESOLUTION NO. BG-2023-056

WHEREAS, the **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)**, through the CY 2023 Corporate Operating Budget (COB), has undertaken the **Rebidding for the Procurement of Various IT Equipment and Software 2023 for Lot 1 (BTC Conference Room Enhancements and BTC Digital Bulletin Board Project)** with an Approved Budget for the Contract (ABC) of **SIX MILLION SEVEN HUNDRED THOUSAND PESOS and 00/100 (Php 6,700,000.00)**, inclusive of all applicable taxes and fees. Breakdown as follows:

WHEREAS, the Bids and Awards Committee for Goods (**BAC-G**), through its Secretariat, advertised/posted the Invitation to Bid including the bidding documents on 15 November 2023 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G conducted the Pre-bid Conference on 22 November 2023, which was attended by the following prospective bidders:

- a. Ynzal Marketing Corporation; and
- b. CIM Technologies Inc.

WHEREAS, BAC-G issued Bid Bulletin No. 1 dated 29 November 2023 clarifying queries raised by the prospective bidders during the pre-bid conference and subsequently, via e-mail;

WHEREAS, in response to said advertisement, Meta-Tech Solutions and Systems Corp., is the sole bidder that submitted bid proposal before the deadline at 9:00 AM on 06 December 2023;

WHEREAS, during the Opening of eligibility and technical documents on 06 December 2023 at 10:00 AM, BAC-G noted that Meta-Tech Solutions and Systems Corp. was rated passed for both the eligibility and technical proposals

WHEREAS, the financial proposal was opened after passing the initial evaluation of the eligibility and technical requirements and being rated as eligible, and the following were noted:

WHEREAS, from 06 December 2023 to 11 December 2023, BAC-G conducted a detailed bid evaluation of the bidding documents of the sole bidder and noted the following:

- a. The bid proposal submitted by the sole bidder was found to be compliant with the legal and technical requirements;
- b. Based on the submitted financial bid, BAC-G declared Meta Tech Solutions and Systems Corp. as the Single Calculated Bidder (SCB) for the Rebidding of the Procurement of Various IT Equipment and Software 2023 for Lot 1 (BTC Conference Room Enhancements and BTC Digital Bulletin Board Project).

WHEREAS, the BAC-G Technical Working Group (TWG) recommended that Meta-Tech Solutions and Systems Corp. undergo a post qualification within the period **12-22 December 2023** pursuant to Section 34 of Rule X – Post-Qualification of the 2016 Revised Implementing Rules and Regulations (RIRR) of the RA No. 9184;

WHEREAS, BAC-G deliberated on the results of the post-qualification and found Meta-Tech Solutions and Systems Corp. as legally, technically, and financially capable to undertake the project;

NOW, THEREFORE, We, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**:

1. To declare the bid of **Meta-Tech Solutions and Systems Corp.** as the Single Calculated and Responsive Bid (SCRB) for the **Rebidding for the Procurement of Various IT Equipment and Software 2023 for Lot 1 (BTC Conference Room Enhancements and BTC Digital Bulletin Board Project)** in the amount of **Six Million Six Hundred Thousand Eight Hundred Eighty-Eight Pesos and 00/100 Only (Php 6,600,888.00)**, inclusive of VAT and all applicable taxes and fees;

2. To recommend the award of contract to Meta-Tech Solutions and Systems Corp.; and
3. To direct the Information and Communications Technology Department (ICTD), being the end-user unit, to submit to BAC-G the Notice of Award, Notice to Proceed, and the duly executed agreement/contract within the prescribed period.
