WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through the General Appropriations Act (GAA), intends to apply the sum of **ONE HUNDRED TEN MILLION SIX HUNDRED** SIXTY FOUR THOUSAND AND 00/100 (Php110,664,000.00), inclusive of VAT and all other applicable government taxes, fees, and charges, being the Approved Budget for the Contract (ABC) to payments under the contract for the Procurement of a Service Provider for the Interim Operations and Maintenance (O&M) of the New Clark City (NCC) Sports Facilities under a Fifteen (15)-Month Service Contract.

Bids and Awards Committee for Goods (BAC-G) CY 2024 Annual Procurement Plan attached as "Annex A".

WHEREAS, on 03 May 2024, BAC-G, through its Secretariat, advertised/posted the Invitation to Bid including the bidding documents on the following platforms:

- DBM Philippine Government Electronic Procurement System (PhilGEPS); a.
- b. BCDA Website; and,
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G conducted a Pre-bid Conference on 14 May 2024 at 01:00 PM, which was attended by the following prospective bidders:

- a. Atalian Global Services Philippines Inc;
- b. Omniworx, Inc;
- NBS Construction; and, C.
- SosaJB Property Management Corp.

WHEREAS, in response to said advertisements, only Atalian Global Services Philippines, Inc. ("Atalian") submitted bids before the deadline of submission on 28 May 2024 (Tuesday) at 10:00 AM, at the BCDA Corporate Center, Bonifacio Global City, Taguig City;

WHEREAS, during the Opening of Bids on 28 May 2024 (Tuesday) at 10:00 AM, in BCDA Corporate Center, Bonifacio Global City, Taguig City, BAC-G received and opened the bids from the "Atalian" and noted it passed the eligibility and technical requirements, thus, its financial envelope was opened and subjected to a preliminary evaluation by determining the presence or absence of the required financial documents using a "pass/fail" criterion;

WHEREAS, BAC-G, through the Technical Working Group (TWG), proceeded with the detailed evaluation of the submitted Financial Proposal of the eligible bidder, to wit:

WHEREAS, in view of the results of the detailed evaluation and consistent with Section 34 of Rule X - Post-Qualification of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) No. 9184, "Atalian", as the bidder with the Single Calculated Bid (SCB), was subjected to Post-Qualification to determine if it is legally, technically, and financially capable to undertake this procurement and responsive to all bidding requirements, including the specifications/terms of reference as stated in the bidding documents;

WHEREAS, during the post-qualification, TWG conducted a further review of the financial bid of "Atalian" and found out that the total amount of bid is as follows:

"34.4 If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower."

WHEREAS, during the conduct of Post Qualification, Atalian confirmed that the total amount of its financial bid is only PhP103,240,288.40 as against the TWG computation of PhP105,349,951.33. "Atalian" also confirmed that it will deliver the requirements stated in the bidding documents of this project and is aware that the equipment stated in this project will eventually become property of BCDA once the project is completed, as detailed below:
