RESOLUTION NO. BG-2024-028

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through its 2024 Corporate Operating Budget (COB), intends to procure the services of **two (2)** Appraisal Companies for the Valuation of Various BCDA Properties ("The Project"), which consists of two (2) Lots - Lot 1 and Lot 2;

WHEREAS, BCDA intends to apply the amount of PESOS: ONE MILLION EIGHT HUNDRED SIXTY-TWO THOUSAND FIVE HUNDRED SIXTY and 00/100 (Php1,862,560.00), inclusive of Value Added Tax (VAT) and all other applicable government taxes, charges and fees, corresponding to the Approved Budget for the Contract (ABC) per Lot;

WHEREAS, the total ABC of THREE MILLION SEVEN HUNDRED TWENTY-FIVE THOUSAND ONE HUNDRED TWENTY PESOS and 00/100 (Php3,725,120.00), inclusive of VAT and all other applicable government taxes, charges, and fees, shall correspond to the procurement of two (2) Appraisal Companies with the Lowest Calculated And Responsive Bids;

Bids and Awards Committee for Goods (BAC-G) CY 2024 Annual Procurement Plan attached as "Annex A".

WHEREAS, on 07 June 2024, the BAC-G, through its Secretariat, advertised/posted the Invitation to Bid including the bidding documents in the following platforms:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, the BAC-G conducted a Pre-bid Conference on 14 June 2024 at 01:00 PM, which was attended by the following prospective bidders:

- a. Asian Appraisal Company Inc.;
- b. 438 Realty and Brokerage; and
- c. Cesson.

WHEREAS, the BAC-G issued Bid Bulletin No. 02 dated 28 June 2024 clarifying queries raised by the prospective bidders during the pre-bid conference and via email;

WHEREAS, the prospective bidders have the option to submit a bid offer on any or all lots, and evaluation and contract award will be undertaken on a per-lot basis;

WHEREAS, in response to said advertisements, one (1) bidder, Asian Appraisal Company Inc. submitted their bids for all the project lots before the deadline of submission of bids at 9:00 AM on 05 July 2024 (Friday) at the BCDA Corporate Center, Bonifacio Global City, Taguig City;

WHEREAS, during the Opening of Bids on 16 July 2024 (Tuesday) at 1:00 PM, the bid submission of Asian Appraisal Company Inc. was opened and subjected to a preliminary examination of bids by determining the presence or absence of the required documents using the "pass/fail" criterion;

WHEREAS during the said preliminary examination of bids and after checking the sufficiency of the required documents as regards their presence or absence, the BAC-G declared the bid of Asian Appraisal Company Inc. as "failed" due to Non-submission of Supporting Documents for the Statement of the bidder's Single Largest Completed Contract (SLCC) as required in Section 23.1 (a) (v) of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (R.A.) No. 9184, also known as the "Government Procurement Reform Act";

WHEREAS, based on the aforementioned, the BAC-G declared a failure of bidding for the Procurement of Appraisal Services for the Valuation of Various BCDA Properties for 2024 (Lot 1) pursuant to Section 35.1 of the 2016 RIRR of R.A. No. 9184, to wit:

"35.1 The BAC shall declare the bidding a failure when:

XXX

c) All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation; xxx." (Emphasis supplied)

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for Goods, hereby RESOLVE as it is hereby **RESOLVED** to recommend the following:

- 1. To declare a Failure of Bidding for the Procurement of Appraisal Services for the Valuation of Various BCDA Properties for 2024 (Lot 1) in accordance with Section 35.1 of the 2016 RIRR of R.A. No. 9184; and
- To direct the end-user, Land and Assets Development Department (LADD) to conduct a 2. mandatory review and evaluation of the terms, conditions, and specifications of the Bidding Documents, including the cost estimates, and other requirements relative to this procurement, pursuant to Section 35.2 of the 2016 RIRR of R.A. No. 9184.

"35.1 The BAC shall declare the bidding a failure when:

c) All bids <u>fail to comply with all the bid requirements</u> or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation; xxx"

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

To direct the end-user, Land and Assets Development Department (LADD) to conduct a mandatory review and evaluation of the terms, conditions, and specifications of the Bidding Documents, including the cost estimates, and other requirements relative to this procurement, pursuant to Section 35.2 of the 2016 RIRR of RA 9184.
