**PROCUREMENT OF BCDA GLOBAL NAVIGATION SATELLITE SYSTEM (GNSS)
BASE/ROVER PACKAGE WITH COMPLETE GNSS TERRESTRIAL BUNDLE SOFTWARE**

**RESOLUTION NO. BG-2024-031
(FAILURE OF BIDDING)**

WHEREAS, the **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)**, through its 2024 Corporate Operating Budget (COB), has bid out the Procurement of BCDA Global Navigation Satellite System (GNSS) Base/Rover Package with Complete GNSS Terrestrial Bundle Software with an Approved Budget for the Contract (ABC) of **FIVE MILLION NINE HUNDRED THOUSAND PESOS and 00/100 (Php5,900,000.00)**, inclusive of VAT and all other applicable government taxes, fees, and charges;

WHEREAS, the Bids and Awards Committee for Goods (BAC-G) advertised/posted the Invitation to Bid, including the bidding document on 21 June 2024 in the following platforms:

- a. Philippine Government Electronic Procurement System (PhilGEPS) website;
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G has conducted a Pre-bid Conference on 28 June 2024, which was attended by the following prospective bidders:

- a. Bay Core Precision Philippines, Corp.;
- b. Argotek Incorporated; and
- c. SITECH Philippines

WHEREAS, BAC-G issued Bid Bulletin No. 1 dated 08 July 2024 clarifying queries raised by the prospective bidders during the pre-bid conference and via email;

WHEREAS, in response to the advertisement, only one (1) bidder, Bay Core Precision Philippines, Corp. submitted their bid before the deadline of submission on 15 July 2024 (Monday) at 9:00 AM at the BCDA Corporate Center, Bonifacio Global City, Taguig City;

WHEREAS, during the Opening of Bids on 22 July 2024 at 10:00 AM, BAC-G opened the bid submission of the sole bidder, Bay Core Precision Philippines, and was rated "*passed*" for both the eligibility and technical proposals;

WHEREAS, the financial proposal of the sole bidder was opened after passing the initial evaluation, and noted the following (*copy of Abstract of Bids as Read is attached as Annex A*);

WHEREAS, during the presentation of the detailed bid evaluation on 29 July 2024, BAC-G declared Bay Core Precision Philippines NON-COMPLIANT for its failure to submit the Committed Line of Credit, which is required under Section 23 of the 2016 Revised Implementing Rules and Regulations (RIRR) of RA 9184;

WHEREAS, BAC-G declared a failure of bidding for the **Procurement of BCDA Global Navigation Satellite System (GNSS) Base/Rover Package with Complete GNSS Terrestrial Bundle Software** pursuant to Sections 35.1 of the 2016 RIRR of RA 9184, viz:

“35.1 The BAC shall declare the bidding a failure when:

xxx

- c) All bids **fail to comply with all the bid requirements** or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation;
xxx”*

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

1. To declare a Failure of Bidding for the **Procurement of BCDA Global Navigation Satellite System (GNSS) Base/Rover Package with Complete GNSS Terrestrial Bundle Software** in accordance with Section 35.1 of the 2016 RIRR of RA 9184; and
2. To direct the end-user, Land and Assets Development Department (LADD) to conduct a mandatory review and evaluation of the terms, conditions, and specifications of the Bidding Documents, including the cost estimates, and other requirements relative to this procurement, pursuant to Section 35.2 of the 2016 RIRR of RA 9184.
