This Bid Bulletin clarifies the queries raised during the Pre-bid Conference on 07 November 2024 at 1:00 PM and other matters related to the above Project.

A. QUERIES/QUESTIONS FROM THE PROSPECTIVE BIDDERS

	QUERY	CLARIFICATION				
1.	Clarification on the 20% administration fee: Can we bid below 20%?	No, per DOLE Order No. 150-16, the standard administrative fee shall not be less than 20% of the total contract cost.				
2.	Clarification regarding the ongoing contract: Do we need to attach supporting documents?	No, the Bidder must submit only a Statement of All its Ongoing and completed Government and Private Contracts during the bid submission, subject to validation during the post-qualification process.				
3.	Clarification on the number of copies of bidding documents the bidders should submit.	Only one (1) copy is required.				
4.	Are we mandated to do the ocular visit?	Yes, this is an eligibility requirement. BCDA will issue a Certificate of Attendance after the site inspection.				
5.	Clarification on the components of K9 Services deployment, as the K9 only renders a maximum of 2-hours of duty per day.	Deployment of K9 will be on an "As Needed" basis only. As stated, the mobilization of K9 is defined in the Terms of Reference.				
6.	Clarification on the number of CCTV units required to be installed in the location.	The number of CCTV Cameras can be determined only once the actual turnover of AOR V is done. Certain areas are still under CJHDEVCO control and cannot be accessed to conduct inspection.				
7.	With the Approved Budget for the Contract of 11,837,550.00, can we clarify if we can re-negotiate after the bidding since the number of cameras, installation, and total cost is yet to be determined?	No. The amount provided in the bid shall be the final amount to be applied in the contract.				
8.	On the number of raised factors in a year: Are we observing 395 days including weekends and holidays observation?	As per PADPAO rates, it is 396 days. (refer to "Annex A")

9. Are we observing the existing labor laws and standards?	Yes.
10. Are we observing the existing labor laws of DOLE 150-16 paragraph (r) with the manner of retirement benefit?	Yes, as mandated by law.
