RESOLUTION NO. BG-2024-044

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through its 2024 Corporate Operating Budget (COB), intends to procure an Additional Fifty (50) Security Guards for Camp John Hay ("The Project"), with an Invitation to Bid No. (reference no.)/Project ID No. of BG2024-315;

WHEREAS, the project has a total Approved Budget of the Contract (ABC) of ELEVEN MILLION EIGHT HUNDRED THIRTY-SEVEN THOUSAND FIVE HUNDRED FIFTY PESOS (Php11,837,550.00), inclusive of VAT and all other applicable government taxes, charges, and fees.

Bids and Awards Committee for Goods (BAC-G) CY 2024 Annual Procurement Plan is attached as "Annex A".

WHEREAS, on 30 October 2024, BAC-G, through its Secretariat, advertised/posted the Invitation to Bid, including the bidding documents, on the following platforms:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G conducted a Pre-bid Conference on 07 November 2024 at 1:00 PM, which was attended by the following prospective bidders:

- a. Envisage Security Agency, Inc.;
- b. Masada Security Agency, Inc.;
- c. Circa Security and Investigation, Inc.; and
- d. Urduja Security Services, Inc.

WHEREAS, BAC-G issued Bid Bulletin No. 01 dated 12 November 2024, providing the presentations discussed during the Pre-Bid Conference;

WHEREAS, BAC-G issued Erratum to Bid Bulletin No. 01 dated 14 November 2024, providing the revised response to a specific query included in the Bid Bulletin;

WHEREAS, in response to said advertisement, one bidder, URDUJA SECURITY SERVICES, INC., submitted its bids for the Procurement of Additional Fifty (50) Security Guards for Camp John Hay before the deadline of submission of bids at 9:00 AM on 19 November 2024 (Monday) at the BCDA Corporate Center, Bonifacio Global City, Taguig City;

WHEREAS, during the Opening of Bids at 10:00 AM on 19 November 2024 (Tuesday) at the BCDA Corporate Center, Bonifacio Global City, Taguig City, BAC-G opened the eligibility and technical documents of the sole bidder to determine its compliance with the requirements of the project;

WHEREAS, after confirming that it met the eligibility and technical criteria, the financial envelope submitted by URDUJA SECURITY SERVICES, INC. was opened and underwent a preliminary evaluation to determine the presence or absence of the required financial documents using a "pass/fail" criterion;

WHEREAS, BAC-G, through the Technical Working Group (TWG), proceeded with the detailed evaluation of the submitted Financial Proposal of **URDUJA SECURITY SERVICES, INC.** and noted the following:

WHEREAS, in view of the results of the detailed bid evaluation and consistent with Section 34 of Rule X – Post-Qualification of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (R.A.) No. 9184, URDUJA SECURITY SERVICES, INC. as the Single Calculated Bidder (SCB), was subjected to Post-Qualification to determine if it is legally, technically, and financially capable to undertake this procurement and responsive to all bidding requirements, including the specifications/terms of reference as stated in the bidding documents;

The Detailed Bid Evaluation Report and the Abstract as Calculated is hereto attached as Annex C;

WHEREAS, pursuant to Section 34.4 of the 2016 RIRR of R.A. No. 9184, which states that,

"If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower".
