ONEWEST OFFICE AND NEW CLARK CITY (NCC)**

**RESOLUTION NO. BG-2024-057**

The **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)**, through the CY 2024 Corporate Operating Budget (COB), has undertaken the **Procurement of the Internet of Things (IoT) Additional Devices for BCDA OneWest Office and NCC** with an Approved Budget for the Contract (ABC) of **One Million Five Hundred Thousand Pesos and 00/100 (PhP 1,500,000.00)**, inclusive of VAT and all other applicable government taxes and fees.

**WHEREAS**, the Bids and Awards Committee for Goods (**BAC-G**), through its Secretariat, advertised/posted the Invitation to Bid, including the bidding documents on 31 October 2024 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

**WHEREAS**, BAC-G conducted the Pre-bid Conference on 08 November 2024, which was attended by one (1) prospective bidder, **PACKETWORX, INC.**

**WHEREAS**, BAC-G issued Bid Bulletin No. 01 dated 15 November 2024, clarifying the issues raised during the pre-bid conference and queries received via email.

**WHEREAS**, in response to said advertisement, one bidder, **PACKETWORX, INC.**, submitted its bids for the Procurement of the Internet of Things (IoT) Additional Devices for BCDA OneWest Office and NCC before the deadline of submission of bids at **9:00 AM on 22 November 2024 (Friday)** at the BCDA Corporate Center, Bonifacio Global City, Taguig City;

**WHEREAS**, during the Opening of Bids at **10:00 AM on 22 November 2024 (Friday)** at the BCDA Corporate Center, Bonifacio Global City, Taguig City, BAC-G opened the eligibility and technical documents of the sole bidder to determine its compliance with the requirements of the project;

**WHEREAS**, after confirming that it met the eligibility and technical criteria, the financial envelope submitted by **PACKETWORX, INC.** was opened, and underwent a preliminary evaluation to determine the presence or absence of the required financial documents using a “pass/fail” criterion;

**WHEREAS**, BAC-G, through the Technical Working Group (TWG), proceeded with the detailed evaluation of the submitted Financial Proposal of **PACKETWORX, INC.** and noted the following:

**WHEREAS**, in view of the results of the detailed bid evaluation and consistent with Section 34 of Rule X – Post-Qualification of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (R.A.) No. 9184, **PACKETWORX, INC.** as the Single Calculated Bidder (SCB), was subjected to Post-Qualification to determine if it is legally, technically, and financially capable to undertake this procurement and responsive to all bidding requirements, including the specifications/terms of reference as stated in the bidding documents;

**WHEREAS**, Section 34.4 of the 2016 RIRR of R.A. No. 9184 states that:

*"If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower".*

**WHEREAS**, on 11 December 2024, during the Deliberation of the Results of Post-Qualification, BAC-G declared **PACKETWORX, INC.** as eligible, technically, legally, and financially capable to undertake the project and recommended declaring **PACKETWORX, INC.** as the bidder with Single Calculated and Responsive Bid (SCRB) for this Project;

- To direct the **Information Communications and Technology Department (ICTD)**, being the end-user unit, to submit to the BAC-G the duly conformed Notice of Award (NOA), duly executed agreement/contract, and Notice To Proceed (NTP)
