DECLARATION OF LOWEST CALCULATED AND RESPONSIVE BID (LCRB)

The BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through the General Appropriations Act (GAA), has put on bid the CONSTRUCTION OF PERIMETER FENCE AND UPGRADING OF UN AVENUE AT MORONG DISCOVERY PARK with an Approved Budget for the Contract (ABC) in the sum of Pesos: Three Hundred Thirteen Million Seven Hundred Sixteen Thousand Three Hundred Forty Pesos and 64/100 Centavos (Php 313,716,340.64), inclusive of all applicable taxes and fees.

WHEREAS, the BAC-I, through its Secretariat, advertised the Invitation to Bid on 27 September 2024 on the following platforms:

WHEREAS, on 06 November 2024, the first envelopes which contained the Eligibility and Technical Requirements of the sixteen (16) proponents were opened and subjected to a preliminary evaluation by determining the presence or absence of the required documents using the "pass/fail" criterion;

WHEREAS, during the said preliminary evaluation and after checking the sufficiency of the required documents as regards their presence or absence, the BAC-I declared that the bids of the following bidders as "failed" due to the absence of the required documents or non-compliance with the requirements provided under the bidding documents for the project, to wit:

WHEREAS, the second envelopes, which contained the financial proposals of the six (6) proponents who "passed" the preliminary examination of the eligibility/technical requirements, were opened and were likewise subjected to a preliminary evaluation of the financial proposals. After checking the sufficiency of the required documents as regards its presence or absence, the BAC declared the bids of the six (6) proponents "passed" and were considered for the detailed evaluation and comparison of financial bids. WHEREAS, on 07 to 13 November 2024, in accordance with Section 32.2 of the RIRR of R.A. 9184 mentioned above, the BAC Technical Working Group (TWG) conducted the detailed evaluation of the Financial Component of the bids of the aforementioned 6 proponents. After the said detailed evaluation of the Financial Component, the six (6) proponents were ranked in ascending order based on their financial bids or total bid price as calculated, evaluated, and/or corrected for computational errors to identify the bidder with the Lowest Calculated Bid (LCB) who shall undergo the post-qualification. The table below shows the bid amount of the six (6) proponents (as calculated):

WHEREAS, three (3) bidders submitted request for reconsideration, pursuant to Section 55.1 of the 2016 RIRR of RA 9184, and upon deliberation, the BAC-I reached the following decisions:



WHEREAS, PERRC, Inc., and Tokwing Construction Corporation/Radians Builders and Supply Corporation (Joint Venture) had until 19 November 2024, and Totowao Development Corporation until 21 November 2024 to file their protest, if any, in accordance with Section 55.3 of the RIRR of RA 9184;

WHEREAS, the above-mentioned disqualified bidders whose requests for reconsideration were denied by the BAC-I did not file any protest within the prescribed period under Section 55.3 of the RIRR of RA 9184.

WHEREAS, Section 32.2 of the RIRR of R.A. 9184 states, "For the procurement of Goods and Infrastructure Projects, the BAC shall evaluate the financial component of the bids to determine the Lowest Calculated Bid. xxx."

Lowest Calculated Bid (LCB) who shall undergo the Post-Qualification process pursuant to Section 34 of the RIRR of R.A. 9184;

WHEREAS, from 14 to 25 November 2024, the BAC-I TWG conducted the Post-Qualification on the C.M. Pancho Construction Inc., pursuant to Section 34 of the RIRR of R.A. 9184;

WHEREAS, on 25 November 2024, the BAC-I TWG requested for an extension of four (4) calendar days to complete the Post-Qualification of C.M. Pancho Construction, Inc. due to the need to further validate the status of the ongoing projects of the said bidder, extending the Post-Qualification period until 29 November 2024;

WHEREAS, upon further validation on the ongoing projects of C.M. Pancho Construction, Inc., TWG observed that they have a Project with DPWH which was not included in the list of their ongoing projects. Upon verification and coordination with DPWH Central Office, the BAC-I confirmed that the project has already been completed on 17 September 2024 as evidenced by the Certificate of Completion dated 13 November 2024.

WHEREAS, based on its findings, the BAC-I declared C.M. Pancho Construction, Inc., as the bidder with the Lowest Calculated and Responsive Bid.

NOW, THEREFORE, foregoing considered and after careful evaluation and thorough deliberation of the bids submitted for the project, we, the Members of the Bids and Awards Committee for Infrastructure Projects (BAC-I), hereby RESOLVE as it is hereby RESOLVED to recommend the following:

- To declare C.M. PANCHO CONSTRUCTION, INC. as the bidder with the Lowest Calculated and Responsive Bid (LCRB) amounting to Pesos: Two Hundred Fifty Million Five Hundred Forty-Six Thousand One Hundred Thirty-One Pesos and 63/100 Centavos (Php 250,546,131.63), inclusive of all applicable taxes and fees, for the CONSTRUCTION OF PERIMETER FENCE AND UPGRADING OF UN AVENUE AT MORONG DISCOVERY PARK; and
- 2. To recommend to the BCDA Board of Directors, for approval, the award of the contract to the C.M. PANCHO CONSTRUCTION, INC. in the amount of Pesos: Two Hundred Fifty Million Five Hundred Forty-Six Thousand One Hundred Thirty-One Pesos and 63/100 Centavos (Php 250,546,131.63), inclusive of all applicable taxes and fees.
