## PROCUREMENT OF FIT OUT PROJECT FOR THE 605.31 SQ.M. BCDA OFFICE SPACE

## **RESOLUTION NO. 2024-022**

The BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through its 2024 Corporate Operating Budget, has put on bid the **Fit Out Project for the 605.31 sq.m. BCDA Office Space** with an Approved Budget for the Contract (ABC) in the sum of **Pesos: Five Million Two Hundred & 00/100 (Php 5,200,000.00),** inclusive of all applicable taxes and fees.

**WHEREAS**, the BAC-I, through its Secretariat, advertised the Invitation to Bid on 16 November 2024 on the following platforms:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, no bid was received for the said project on the date of the deadline of bid submission. Thus, the BAC-I declared a failure of bidding for the Fit Out Project for the 605.31 Sq.m. BCDA Office Space pursuant to Section 35.1 (a) of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act No. (RA) 9184, viz:

"35.1 The BAC shall declare the bidding a failure when:

a) no bids were received

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee for Infrastructure Projects, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

- 1. To declare a Failure of Bidding for the **Fit Out Project for the 605.31 Sq.m. BCDA Office Space** in accordance with Section 35.1 of the 2016 RIRR of RA 9184; and
- 2. To direct the end-user, PPMD General Services Division (PPMD-GSD) to conduct a mandatory review and evaluation of the terms, conditions, and specifications of the Bidding Documents, including the cost estimates and other requirements relative to this procurement, pursuant to Section 35.2 of the 2016 RIRR of RA 9184.
