- g. Contractor's All Risk Insurance; and
- h. Personal Accident Insurance.
- 2. Post a Performance Security denominated in Philippine Pesos in the form and in the amount stipulated under Section 39.2 of the revised IRR of Republic Act No. 9184, which shall be posted in favor of BCDA and which shall remain valid until the issuance of Certificate of Final Acceptance.

Failure to enter into the said contract and/or provide the Performance Security shall constitute sufficient ground for cancellation of this award and forfeiture of your Bid Security.
