    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental Bid Bulletins, if any;







2.2. Winning Bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- 2.4. Notice of Award of Contract; and the Bidder's conforme thereto; and

In consideration for the sum of One Million Five Hundred Thousand and 00/100 (PhP1,500,000.00) inclusive of all applicable taxes, fees and charges, CAL-FIL APPRAISAL AND MANAGEMENT INC. agrees to render the Appraisal Services for Various BCDA Properties 2024 Appraiser 1, in accordance with its Bid.
- 4. The **BCDA** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


