This Bid Bulletin clarifies the queries raised during the Pre-bid Conference on **18 February 2025** at **10:00 AM** and other matters related to the above Project.

A. QUERIES/QUESTIONS FROM THE PROSPECTIVE BIDDERS

QUERY	CLARIFICATION
1. How many copies of Technical and Financial Eligibility Documents must be submitted?	<i>One (1) copy for Eligibility and Technical Component envelope, and One (1) copy for Financial Documents.</i>
2. Clarification on the Single Largest Completed Contracts (SLCC): The SLCC must be related to the Adobe Project?	<i>The bidder must have completed, within the period specified in the Invitation to Bid a Single Contract that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC. (For this purpose "similar contracts" shall refer to contracts involving the provision of engineering and architectural IT Software graphic design).</i>
3. Is the certification for engineers included in the technical requirements?	<i>No. Certification is needed for technical support. Authorized technical support for the supplier will be accepted.</i>
4. Clarification on all unit items, are we required to bid on all items for Lot 1 - Adobe?	<i>The bidder must bid on all items in a lot. Bidders who did not bid for all items in a lot shall be automatically rejected at bid opening, and bids received in excess of the Approved Budget for the Contract (ABC) for each item shall also be automatically rejected at bid opening.</i>
5. Clarification on the allotted unit price per item, if we can exceed the Approved Budget for the Contract (ABC)?	<i>No, Bids received in excess of the total cost per line item and total ABC for the lot shall be automatically rejected at bid opening.</i>
6. Clarification on the Technical Specification of all licensed software needs to be renewed.	<i>All software licenses will have a new VIP number.</i>
7. Clarification on the qualifications of the technical support personnel, does it need to be a certified/qualified application engineer?	<i>No. Authorized technical support for the supplier will be accepted.</i>
8. Is the location of the Installation in the main office only?	<i>All installation will be done by BCDA through the online link provided by Adobe.</i>
