PROCUREMENT OF ONE (1) YEAR RENTAL OF TWENTY-EIGHT (28) MULTIFUNCTION COLOR COPY MACHINES FOR CY 2025

RESOLUTION No. BG-2025-008

WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through its 2025 Corporate Budget, applied the sum of Three Million Six Hundred Thousand Pesos (Php3,600,000.00), inclusive of VAT and all applicable government taxes, fees, and charges, as the Approved Budget for the Contract (ABC) for the Procurement of One (1) Year Rental of Twenty-Eight (28) Multifunction Color Copy Machines for CY 2025;

WHEREAS, the BAC for Goods (BAC-G), through its Secretariat, advertised the Invitation to Bid on 21 January 2025 in the following platforms:

- 1. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- 2. BCDA Website; and,
- 3. Conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G conducted a Pre-bid Conference on 06 February 2025 which was attended by the following prospective bidders, namely:

- 1. iSource Asia Business Solutions; and
- 2. Otus Copy Systems, Inc.

WHEREAS, in response to said advertisements, a sole bidder, Otus Copy Systems, Inc., submitted its bid for the project before the deadline of submission at 9:00 AM on 20 February 2025;

WHEREAS, during the Opening of Bids on 20 February 2025 at 10:00 AM, BAC-G opened the technical and financial bids submitted by the above-mentioned bidder and rated the same as "passed".

WHEREAS, on 21 February 2025, BAC-G conducted a detailed bid evaluation of the bidding documents of the sole bidder and found that the bid proposal submitted by Otus Copy Systems, Inc. to be compliant with its legal and technical requirements, and hence, declared Otus Copy Systems, Inc. as the Single Calculated Bidder (SCB). Moreover, its financial bid as calculated, as shown in the table below, is within the ABC:

WHEREAS, BAC-G recommended Otus Copy Systems, Inc. to undergo a post qualification from 26 February to 11 March 2025, pursuant to Section 34 of Rule X - Post-Qualification of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, based on results of the post qualification, the BAC-G Technical and Working Group (TWG) found that Otus Copy Systems, Inc. is legally compliant and responsive to the eligibility, technical, and financial requirements, per specifications and other terms in the bidding documents;

WHEREAS, on 11 March 2025, BAC-G deliberated the results of the post qualification of Otus Copy Systems, Inc., based on the TWG Report. BAC-G found that Otus Copy Systems, Inc. is legally, technically, and financially capable to undertake the project. (The Post-Qualification Report is hereto attached as "Annex C")

ACCORDINGLY, we, the members of the Bids and Awards Committee for Goods, hereby RESOLVE, as it is hereby RESOLVED:

- 1. To declare Otus Copy Systems, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Procurement of One (1) Year Rental of Twenty-Eight (28) Multifunction Color Copy Machines for CY 2025:
- 2. To award the contract to Otus Copy Systems, Inc. with the amount of Two Million Nine Hundred Seventy-Two Thousand Pesos Only (Php2,972,000.00), inclusive of VAT and all applicable government taxes and fees;
- 3. To issue a corresponding Notice of Award (NOA) to Otus Copy Systems, Inc. (Copy Attached); and
- 4. To direct the BCDA Information and Communications Technology Department (ICTD), being the end-user unit, to submit to the BAC-G the duly conformed Notice to Proceed, and the duly executed agreement/contract.
