RESOLUTION NO. BG-2023-003

The BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through the CY 2022 General Appropriations Act (GAA), has undertaken the Procurement of the Operation and Maintenance of the New Clark City Sports Facilities: Supply, Delivery, and Installation of Furniture, Appliances, Linens and Hardware and Accessories for the National Government Administrative Center Sports Facilities - Lot 1 (Furniture) with an Approved Budget for the Contract (ABC) of Pesos: Six Million Six Hundred Sixty-Six Thousand Thirty-Eight Pesos and 40/100 (PhP 6,666,038.40), inclusive of VAT and all other applicable government taxes and fees;

advertised/posted the WHEREAS, the Bids and Awards Committee for Goods (BAC-G), Invitation to Bid including the bidding documents on 29 October 2022 in the following:

- DBM Philippine Government Electronic Procurement System (PhilGEPS); a.
- BCDA Website; and b.
- In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, the BAC-G conducted a Pre-bid Conference on 7 November 2022, which was attended by the following prospective bidders;

- a. Dargo Design Component Builders Corp.; and
- b. CLC Marketing Ventures Corp.

WHEREAS, in response to the said Invitation, Dargo Design Component Builders Corp. and CLC Marketing Ventures Corp. submitted their bids prior to the deadline for the submission of bids;

WHEREAS, during the Opening of Bids on 25 November 2022 at 1:00 PM, BAC-G received and opened the bid documents of the two (2) bidders and noted the following:

WHEREAS, the two (2) bidders passed the initial evaluation of the eligibility and technical requirements, their financial proposals were opened and BAC-G noted the following:

WHEREAS, on 30 November 2022, the BAC-G Technical Working Group conducted a detailed evaluation of the bid of Dargo Design Component Builders Corp. In view of the results of the Detailed Evaluation of Bids, the BAC-G has declared the bid of Dargo Design Component Builders Corp. as eligible;

The copy of the Detailed Evaluation Report is hereto attached as Annex "B";

WHEREAS, the BAC-G recommended that Dargo Design Component Builders Corp. undergo a post qualification pursuant to Section 34 of Rule X – Post-Qualification of the 2016 Revised Implementing Rules and Regulations (RIRR) of the Republic Act 9184;

WHEREAS, BAC-G deliberated on the results of the post-qualification and found that Dargo Design Component Builders Corp. is non-compliant with various requirements and ineligible to undertake the project;

The Notice of Post Disqualification is hereby attached as **Annex** "C";

WHEREAS, the BAC-G recommended that CLC Marketing Ventures Corp., being the 2nd lowest calculated bid for the project, undergo a post-qualification on 09-12 January 2023, pursuant to Section 34 of Rule X – Post-Qualification of the 2016 Revised Implementing Rules and Regulations (RIRR) of the Republic Act No. 9184;

The Post-Qualification Report is hereby attached as **Annex** "D";

WHEREAS, BAC-G deliberated on the results of the post-qualification and found that CLC Marketing Ventures Corp. is eligible, legally, technically, and financially capable to undertake the project;

NOW, THEREFORE, We, the members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- To declare CLC Marketing Ventures Corp. as the Lowest Calculated and Responsive Bidder (LCRB) for the Procurement of the Operation and Maintenance of the New Clark City Sports Facilities: Supply, Delivery, and Installation of Furniture, Appliances, Linens and Hardware and Accessories for the National Government Administrative Center Sports Facilities Lot 1 (Furniture), and to award the contract in the amount of Pesos: Five Million Eight Hundred Sixty-Nine Thousand Five Hundred Eighty Pesos and 00/100 (Php5,869,580.00), inclusive of VAT and all applicable taxes and fees.
- 2. To direct the Property and Procurement Management Department (PPMD), as the end-user unit, to submit to the BAC-G the duly confirmed Notice of Award, Notice to Proceed, and a signed agreement/contract within the prescribed period.
