The **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)**, through the CY 2025 Corporate Operating Budget (COB) has undertaken the **Procurement of BCDA IT Equipment for 2025** with an Approved Budget for the Contract (ABC) of **Five Million Seven Hundred Forty Thousand Pesos and 0/100 (Php5,740,000.00)**, inclusive of all applicable taxes and fees, as shown below:

- Columbia Technologies Inc. (CTI)

WHEREAS, BAC-G issued Bid Bulletin No. 1 dated 04 March 2025 clarifying queries raised by the prospective bidders during the pre-bid conference and subsequently, via e-mail;

WHEREAS, in response to said advertisements, the sole bidder, Columbia Technologies Inc., submitted its bid before the deadline of submission of bids at 9:00 AM on 11 March 2025;

WHEREAS, during the Opening of Bids on 11 March 2025 at 10:00 AM, BAC-G noted the following:

WHEREAS, consistent with Section 34 of Rule X "Post-Qualification" of the 2016 Revised Implementing Rules and Regulations (RIRR) of RA 9184, the BAC-G Technical Working Group (TWG) conducted a Post-Qualification of Columbia Technologies Inc. from 19 March 2025 to 26 March 2025;

WHEREAS, on 26 March 2025, BAC-G deliberated the results of the post qualification and found that Columbia Technologies Inc. is eligible, technically, and financially capable to undertake the
