**PROCUREMENT OF THE BCDA IT SOFTWARE ANNUAL SUBSCRIPTION 2025**

**RESOLUTION NO. BG-2025-009**

The **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)**, through the 2025 Corporate Operating Budget (COB), has undertaken the **Procurement of the BCDA IT Software Annual Subscription 2025** with an Approved Budget for the Contract (ABC) of **One Million Seven Hundred Fifty Thousand Pesos and 00/100 (PhP1,750,000.00)**, inclusive of all applicable taxes and fees;

**WHEREAS**, the Bids and Awards Committee for Goods (**BAC-G**), through its Secretariat, advertised/posted the Invitation to Bid including the bidding documents on 08 February 2025 in the following:

- a. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

**WHEREAS**, BAC-G conducted the Pre-bid Conference on 18 February 2025 which was attended by the following prospective bidders:

- b. Ynzal Marketing Corporation;
- c. 3GX Computer and I.T Solutions Technoshop;
- d. Masangkay Computer Center (MCC);
- e. Agile Techfrontier Corporation;

- h. Maria Ela Tugay;
- i. Joneco Tech Marketing Corporation; and
- j. Pronet Systems Inc.

**WHEREAS**, BAC-G issued Bid Bulletin No. 01 dated 25 February 2025 clarifying queries raised by the prospective bidders during the pre-bid conference and subsequently, via e-mail.

**WHEREAS**, in response to said advertisements, Integrated Computer Systems Inc. and Ynzal Marketing Corporation submitted bids before the deadline on 04 March 2025;

**WHEREAS**, during the Opening of Bids on 04 March 2025 at 10:00 AM, BAC-G received and opened the bid documents of the two (2) bidders and noted the following observation:

**WHEREAS**, BAC-G deliberated on the results of the post-qualification and found that Ynzal Marketing Corporation is eligible, legally, technically, and financially capable to undertake the project;
