- ANTECEDENTS -

The BCDA invites Bids for certain goods and ancillary services, viz., for the rental of twenty-eight (28) units of color multifunction copy machines for the day-to-day demand of its printing and photocopying services and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Two Million Nine Hundred Seventy-Two Thousand Pesos Only (Php2,972,000.00) , inclusive of VAT and all applicable taxes and fees (herein called "the Contract Price").

- 4. The BCDA hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


