The BASES CONVERSION AND DEVELOPMENT AUTHORITY (hereinafter referred to as BCDA) has applied the sum of Nine Million One Hundred Fifty-Five Thousand Four Hundred Eighty-Four Pesos (Php9,155,484.00) for a period of one (1) year, inclusive of VAT and all applicable taxes and fees, as the Approved Budget for the Contract (ABC), chargeable against the 2025 BCDA Corporate Budget, to payments under the contract for the Procurement of Security Services for AOR III (Bataan Technology Park);

WHEREAS, on 13 March 2025, the Bids and Award Committee for Goods (BAC-G), through its Secretariat, published/advertised the Invitation to Bid in the following:

- 1. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- 2. BCDA Website; and
- 3. Conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, in response to said advertisement, the following companies submitted their respective bids:

- 1. Urduja Security Services; and
- 2. Envisage Security Agency Inc.

WHEREAS, during the Opening of Bids on 02 April 2025, BAC-G received and opened the bidding documents of the above-mentioned bidders. During the opening of the eligibility requirements and technical documents, BAC-G observed the following:

WHEREAS, on 03 April 2025, the BAC-G conducted a detailed bid evaluation of the bidding documents of the two (2) bidders with the following observations:

WHEREAS, BAC-G upon the TWG recommendation, declared Urduja Security Services and Envisage Security Agency Inc as the Lowest Calculated Bidders (LCB) and to undergo a post-qualification, pursuant to Section 34 of Rule X "Post-Qualification" of the RIRR of RA of RA 9184;

The Bid Evaluation Report is hereby attached as Annex "B".

WHEREAS, consistent with Section 34 of Rule X "Post-Qualification" of the RIRR of RA 9184, the BAC-G Technical Working Group (TWG) conducted a Post-Qualification of the bids on 04 April 2025 to 08 April 2025;

WHEREAS, on 08 April 2025, after careful examination, validation, and verification of all the eligibility, technical, and financial documents submitted by the two (2) Lowest Calculated Bidders namely: Urduja Security Services and Envisage Security Agency Inc. the BAC-G, upon the recommendation of the TWG approved the following:

- 1. Both the eligibility documents and financial proposals submitted by **Urduja Security** Services and Envisage Security Agency Inc. were in order;
- 2. **Urduja Security Services** is non-compliant with the performance evaluation of on-going project and non responsive with its clients obligations and deliverables as stated in the performance evaluation; and,
- 3. Envisage Security Agency Inc. is legally, technically, and financially capable to undertake this project and responsive to all bidding requirements including the specifications/terms of reference stated in the bidding documents.

WHEREAS, on 08 April 2025, the BAC-G issued a Notice of Post-Disqualification to Urduja Security Services citing its non compliance ("Annex C");


