STANDARD FIRST AID KIT REQUIREMENTS FOR AOR-VI

A. EMERGENCY ITEMS:

- 1. Emergency Phone Numbers (Nearest Police/Fire Station, Hospital, and other Government Health Facilities/Institutions)
- 2. First-aid Instruction Manual
- 3. Small, waterproof flashlight and extra batteries
- 4. Candles and matches

B. BASIC SUPPLIES:

- 1. Adhesive tape
- 2. Anti-biotic ointment
- 3. Antiseptic solution
- 4. Bandages, including a roll of elastic wrap (Ace, Coban, others) and bandage strips (Band-Aid, Curad, others) in assorted sizes
- 5. Instant cold packs
- 6. Cotton balls and cotton-tipped swabs
- 7. Disposable latex or synthetic gloves (at least two pairs)
- 8. Duct tape
- 9. Gauze pads and roller gauze in assorted sizes
- 10. Petroleum jelly or other lubricant
- 11. Plastic bags for the disposal of contaminated materials
- 12. Safety pins in assorted sizes
- 13. Scissors and tweezers
- 14. Soap or instant hand sanitizer
- 15. Sterile eyewash, such as a saline solution
- 16. Thermometer
- 17. Triangular bandage
- 18. Turkey baster or other bulb suction device for flushing out wounds

C. MEDICATIONS:

- 1. Aloe-Vera gel
- 2. Anti-diarrhea medication
- 3. Over-the counter oral Antihistamine; Diphenhydramine, Benadryl, others
- 4. Aspirin and non-aspirin pain relievers.
- 5. Calamine lotion
- 6. Over-the-counter hydrocortisone cream
- 7. Personal medications that don't need refrigeration
- 8. Syringe, medicine cup or spoon

Specifications for the Fabrication of a 20-Foot Container Guard Patrol Base House

The fabrication of a 20-foot container into a guard patrol base house requires a comprehensive approach, transforming a standard shipping container into a secure, habitable, and functional facility for security personnel. The following specifications outline the key considerations, from the base container selection to the final outfitting, with a particular emphasis on requirements for a patrol base. These specifications are designed to be adaptable based on specific operational needs and location, including considerations for the climate and regulations in the Philippines.

1. Base Container Specifications

- **Type:** A standard 20-foot (6.1 meters) "one-trip" or new ISO (International Organization for Standardization) shipping container is recommended. These are in excellent structural condition, minimizing the need for initial repairs.
- Material: Corten steel, also known as weathering steel, is the standard material and is valued for its corrosion resistance.
- Dimensions (Standard):
 - o **Exterior:** Approximately 20 ft (L) x 8 ft (W) x 8.5 ft (H) (6.1m x 2.44m x 2.59m).
 - o **Interior:** Approximately 19.4 ft (L) x 7.7 ft (W) x 7.9 ft (H) (5.9m x 2.35m x 2.4m).
- Condition: The container must be wind and watertight, with no holes or major dents. The original flooring, typically marine-grade plywood, should be inspected for any signs of contamination and sealed or replaced as necessary.

2. Structural Modifications

All structural modifications must be engineered to maintain the container's integrity. Reinforcements are crucial around any openings.

- **Personnel Door:** One (1) heavy-duty, outward-swinging steel door with a robust locking system (deadbolt and latch). A viewport and a weather seal are recommended.
- Windows: A minimum of two (2) windows to provide visibility of key areas. These should be sliding or casement-style for ventilation and fitted with:
 - o Security Bars: Welded steel bars on the exterior.
 - o **Insect Screens:** To prevent mosquitos and other pests.
- Rooftop Access (Optional): A reinforced section of the roof can be modified to include a lockable hatch for observation or the mounting of equipment. This area must have a non-slip surface and safety railings.
- **Gun Ports (Optional):** Small, lockable, and sealable ports can be integrated at strategic heights to allow for observation and defense without compromising the structure's security.

3. Interior Layout and Finishing

The interior should be designed for both operational readiness and the basic comfort of the personnel. A common layout includes a main monitoring/work area and a small, partitioned section for rest and sanitation.

Framing and Insulation:

- o **Framing:** Lightweight steel studs or treated wood framing should be used to create the interior walls.
- o **Insulation:** Given the climate in the Philippines, insulation is critical. A minimum of R-13 rated insulation (e.g., spray foam, rigid foam boards, or mineral wool) should be installed in the walls and ceiling to mitigate heat.
- Wall and Ceiling Panels: Moisture-resistant drywall, plywood, or pre-finished wall panels should be used.
- **Flooring:** The original plywood floor should be sealed and covered with a durable, non-slip material such as industrial-grade vinyl sheeting or epoxy coating.
- Partitioning: A partition wall with a door can be installed to create a separate area for a compact sleeping bunk and a small sanitation facility.

4. Electrical and Lighting

All electrical work must be performed by a licensed electrician and comply with the Philippine Electrical Code.

- **Power Supply:** Connection to a main power source with a dedicated circuit breaker panel inside the container. A weatherproof external connection point should be installed. Provision for a backup generator connection is highly recommended.
- Outlets: A minimum of four (4) double-gang outlets should be strategically placed in the main area to power communications equipment, monitors, and other devices. At least one outlet should be available in the resting area.
- Lighting:
 - o **Interior:** Bright, energy-efficient LED lighting in the main area and a separate, softer light in the rest area.
 - Exterior: A powerful, motion-activated floodlight mounted on the exterior to illuminate the surrounding area.

5. Personnel Accommodation and Sanitation

For a patrol base, providing basic amenities for personnel on extended duty is essential.

- Sleeping Quarters: A compact, built-in bunk bed can be installed in the partitioned area.
- Sanitation: A small, well-ventilated wet room should be constructed, including:
 - o **Toilet:** A compact, water-efficient toilet connected to a septic tank or a chemical toilet, depending on the location's infrastructure.
 - o Handwashing Sink: A small sink with a faucet.
 - o **Water Supply:** Connection to a reliable water source. If a direct connection is not possible, a water tank with a pressure pump should be installed on the roof or an adjacent platform.
- **Ventilation:** An exhaust fan must be installed in the sanitation area and the main living space to ensure air circulation and prevent moisture buildup.

6. Security and Defensive Features

A guard patrol base requires enhanced security features beyond a standard guardhouse.

- Reinforced Viewing Areas: Windows can be made of polycarbonate or laminated security glass for increased ballistic resistance.
- Communications: Installation of a radio communication system with an externally mounted antenna. Provision for internet and CCTV monitoring equipment.
- Alarm System: A basic alarm system with sensors on the door and windows.
- Exterior Finish: The container should be painted with a durable, anti-rust paint. A color that blends with the surroundings may be chosen for tactical reasons.

7. Foundation and Siting

- Foundation: The container must be placed on a solid, level foundation to prevent shifting and ensure stability. This can be a concrete slab, concrete piers, or a gravel pad.
- Siting: The placement of the guard patrol base is critical. It should be positioned to have a clear and commanding view of the area it is intended to secure, while also considering potential cover and concealment for the structure itself.

8. Compliance with Philippine Regulations

- National Building Code of the Philippines (PD 1096): While shipping container
 construction is not explicitly detailed in all sections, all modifications, especially
 those related to structural integrity, electrical, and sanitation, must adhere to the
 principles of safe construction as outlined in the code. A building permit from the
 local government unit is generally required.
- Local Ordinances: It is crucial to consult with the local municipal or city engineering office to understand any specific local ordinances or requirements for container-based structures.

By adhering to these specifications, a 20-foot shipping container can be effectively and safely fabricated into a durable and functional guard patrol base house, providing a secure and habitable environment for security personnel.
