WHEREAS, the BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA), through its 2025 Corporate Operating Budget (COB), intends to procure the Integrated Cloud Backup Maintenance (Phase 1, 2 & Hybrid Backup), ("The Project").

WHEREAS, the project has a total Approved Budget of the Contract (ABC) of SIXTEEN MILLION PESOS (Php16,000,000.00), inclusive of VAT and all other applicable government taxes, charges, and fees.

WHEREAS, on 11 June 2025, BAC-G, through its Secretariat, advertised/posted the Invitation to Bid, including the bidding documents, on the following platforms:

- DBM Philippine Government Electronic Procurement System (PhilGEPS); a.
- BCDA Website; and b.
- C. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G conducted a Pre-bid Conference at 10:00 AM on 19 June 2025, which was attended by the following prospective bidders:

- b. Ascend Data Management Inc.
- Sandz Solution Philippines, Inc. c.
- Micro Data Systems Inc. d.

WHEREAS, in response to said advertisement, one bidder, SANDZ SOLUTIONS PHILIPPINES, INC., submitted its bids for the Procurement of Integrated Cloud Backup Maintenance (Phase 1, 2 & Hybrid Backup), before the deadline of submission of bids at 9:00 AM on 03 July 2025 (Thursday) at the BCDA Corporate Center, Bonifacio Global City, Taguig City;

WHEREAS, during the Opening of Bids at 10:00 AM on 03 July 2025 (Thursday) at the BCDA Corporate Center, Bonifacio Global City, Taguig City, BAC-G opened the eligibility and technical documents of the sole bidder to determine its compliance with the requirements of the project;

WHEREAS, after confirming that it met the eligibility and technical criteria, the financial envelope submitted by SANDZ SOLUTIONS PHILIPPINES, INC. was opened and underwent a preliminary evaluation to determine the presence or absence of the required financial documents using a "pass/fail" criterion;

WHEREAS, BAC-G, through the Technical Working Group (TWG), proceeded with the detailed evaluation of the submitted Financial Proposal of SANDZ SOLUTIONS PHILIPPINES, INC and noted the following:

WHEREAS, in view of the results of the detailed bid evaluation and consistent with Section 34 of Rule X -Post-Qualification of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (R.A.) No. 9184, SANDZ SOLUTIONS PHILIPPINES, INC as the Single Calculated Bidder (SCB), was subjected to Post-Oualification to determine if it is legally, technically, and financially capable to undertake this procurement and responsive to all bidding requirements, including the specifications/terms of reference as stated in the bidding documents;

The Detailed Bid Evaluation Report and the Abstract as Calculated is hereto attached as Annex B;

WHEREAS, Section 34.4 of the 2016 RIRR of R.A. No. 9184, states that:

"If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower".

WHEREAS, on 29 July 2025, during the Deliberation of the Results of Post-Qualification, BAC-G declared that SANDZ SOLUTIONS PHILIPPINES, INC., is eligible, technically, legally, and financially capable to undertake the project and recommended declaring SANDZ SOLUTIONS PHILIPPINES, INC. as the bidder with Single Calculated and Responsive Bid (SCRB) for this Project;


