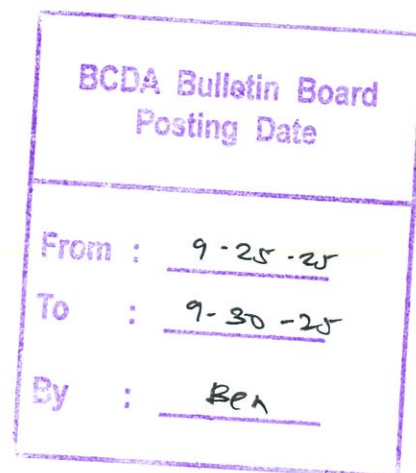

B) Suppliers who have previously submitted the above documentary requirements  
may no longer require its re-submission  
except for the Omnibus Sworn Statement.
