The BASES CONVERSION AND DEVELOPMENT AUTHORITY (hereinafter referred to as BCDA) has applied the sum of Seventeen Million Five Hundred Forty-One Thousand Four Hundred Thirty-Three Pesos (Php 17,541,433.00) for a period of seven (7) months, inclusive of VAT and all applicable taxes and fees, as the Approved Budget for the Contract (ABC), chargeable against the 2025 BCDA Corporate Budget, to payments under the contract for the Procurement of Security Services of AOR IV-D -Additional Security Coverage in New Clark City;

WHEREAS, on 11 June 2025, the Bids and Award Committee for Goods (BAC-G), through its Secretariat, published/advertised the Invitation to Bid in the following:

- 1. DBM Philippine Government Electronic Procurement System (PhilGEPS);
- 2. BCDA Website; and
- 3. Conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, in response to said advertisement, the following companies submitted their respective bids:

- 1. Grand Meritus Security Agency, Inc.;
- 2. Envisage Security Agency, Inc.;
- 3. Philand Security Agency, Inc.; and
- 4. Z-Four Security System, Inc.

WHEREAS, during the Opening of Bids on 03 July 2025 at 1:00 PM, BAC-G received and opened the bidding documents of the above-mentioned bidders. During the opening of the eligibility requirements and technical documents, BAC-G observed the following:

WHEREAS, BAC-G upon the TWG recommendation, declared Grand Meritus Security Agency Inc., Envisage Security Agency Inc., and Philand Security Agency, Inc. as the Lowest Calculated Bidders (LCB) and to undergo a post-qualification, pursuant to Section 34 of Rule X "Post-Qualification" of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) No. 9184;

The Bid Evaluation Report is hereby attached as Annex "B".

WHEREAS, consistent with Section 34 of Rule X "Post-Qualification" of the 2016 RIRR of RA 9184, the BAC-G Technical Working Group (TWG) conducted a Post-Qualification of the bids on 16 July 2025 to 28 July 2025;

WHEREAS, on 12 August 2025, the TWG presented the post-qualification report and requested that the validation of the Certificate of Non-Pending Cases issued by SOSIA-PNP for the three bidders be extended for a period of ten (10) calendar days which is until 22 August 2025;

WHEREAS, the BCDA President and Chief Executive Officer (PCEO) approved the ten (10) calendar days extension of post-qualification period;

The Approved Extension of Post-Qualification Period is hereby attached as Annex "C".

WHEREAS, pursuant to section 34.8 of the 2016 RIRR of RA No. 9184 allows for the extension of the post-qualification period. It provides that:

"The post-qualification process shall be completed in not more than twelve (12) calendar days from the determination of the Lowest Calculated Bid/Highest Rated Bid. In exceptional cases, the post-qualification period may be extended by the HoPE, but in no case shall the aggregate period exceed forty-five (45) calendar days for Goods and Infrastructure Projects, or thirty (30) calendar days in Consulting Services."

WHEREAS, on 28 August 2025, after careful examination, validation, and verification of all the eligibility, technical, and financial documents submitted by the two (2) Lowest Calculated Bidders namely: Grand Meritus Security Agency Inc. and Envisage Security Agency Inc. the BAC-G, upon the recommendation of the TWG approved the following:

3. Grand Meritus Security Agency Inc. and Envisage Security Agency Inc. are legally, technically, and financially capable to undertake this project and responsive to all bidding requirements including the specifications/terms of reference stated in the bidding documents.

The Post-Qualification Report and Supplemental Report are hereby attached as Annex "D"

WHEREAS, upon the deliberation of the post qualification results held on 28 August 2025, BAC-G declared that both Grand Meritus Security Agency Inc. and Envisage Security Agency Inc. have passed the eligibility requirements, technical, and financial components of the Project and both of them have been declared as bidders with the Lowest Calculated and Responsive Bid (LCRB);

WHEREAS, pursuant to Appendix 11 (GPPB Circular 06-2005 Tie Breaking Method) of the 2016 RIRR of RA 9184 and Section 3.3 of the Government Procurement Policy Board (GPPB) Circular No. 06-2005 (Guidelines on the Use of Non-Discretionary/Non-Discriminatory Selection Criteria), there must be a tie breaking method in case of two or more bidders are determined and declared as the Lowest Calculated and Responsive Bid (LCRB);

WHEREAS, on 02 September 2025, the BAC-G issued a Notice of Post-Disqualification to Philand Security Agency, Inc. citing its non compliance ("Annex E");

WHEREAS, on 08 September 2025, the BAC-G issued a Notice to Tie-Breaking Activity to Grand Meritus Security Agency Inc. and Envisage Security Agency Inc. ("Annex F")

WHEREAS, on 11 September 2025, Grand Meritus Security Agency Inc. and Envisage Security Agency Inc. agreed to break the tie via tossing of a coin, pursuant to the existing rules and regulations. Both have participated in the conduct of a tie breaking activity held at the BCDA Corporate Center in Taguig City, facilitated and witnessed by the BAC-G and the Observer from the Commission on Audit. Both of their authorized representatives have signed a tie breaking form signifying their agreement for a tie breaking method in determining the winning bidder for the Project.

WHEREAS, Grand Meritus Security Agency Inc. won in the tie breaking activity (toss coin) and was declared as the Winning Bidder for the Project;

Results of the Tie Breaking Activity are hereby attached as Annex "G".

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE**, as it is hereby **RESOLVED**, the following:

1. To declare and recommend the award of contract to Grand Meritus Security Agency Inc. as the Lowest Calculated and Responsive Bidder (LCRB) for the Procurement of Security Services of AOR IV-D -Additional Security Coverage in New Clark City, with the total amount of SIXTEEN MILLION FOUR HUNDRED EIGHTY-FIVE THOUSAND THREE HUNDRED FORTY-THREE PESOS and 42/100 Only (Php16,485,343.42), inclusive of all applicable taxes and fees; and
