**RESOLUTION NO. BG-2024-047
(FAILURE OF BIDDING)**

WHEREAS, the **BASES CONVERSION AND DEVELOPMENT AUTHORITY (BCDA)**, through its 2024 General Appropriations Act (GAA), has bid out the Procurement of Additional CCTV System and Preventive Maintenance of the Existing CCTV System in the Athletes Village (AV) at the National Government Administrative Center (NGAC) in New Clark City (NCC) with an Approved Budget for the Contract (ABC) of **FOUR MILLION FIVE HUNDRED THOUSAND PESOS (Php4,500,000.00)**, inclusive of VAT and all other applicable government taxes, fees, and charges;

WHEREAS, the Bids and Awards Committee for Goods (BAC-G) advertised/posted the Invitation to Bid, including the bidding documents on 09 November 2024 in the following platforms:

- a. Philippine Government Electronic Procurement System (PhilGEPS) website;
- b. BCDA Website; and
- c. In a conspicuous place reserved for the purpose in the premises of BCDA.

WHEREAS, BAC-G has conducted a Pre-bid Conference on 20 November 2024, which was attended by the following prospective bidders:

- a. Riley Corporation
- b. DGL Veracity Systems Corporation
- c. AGS Facilities Services Phils, Inc.
- d. VastResult, Inc.
- e. MetaTech Solutions and Systems Corporation
- f. Com Parts Computer Sales
- g. AVN Electronic
- h. Macrologic Diversified Technologies, Inc.

WHEREAS, BAC-G issued Bid Bulletin No. 1 dated 25 November 2024 clarifying queries raised by the prospective bidders during the pre-bid conference and via email;

WHEREAS, in response to the advertisement, two (2) bidders, Macrologic Diversified Technologies, Inc. and VastResult, Inc. submitted their bids before the deadline of submission on 02 December 2024 (Monday) at 9:00 AM at the BCDA Corporate Center, Bonifacio Global City, Taguig City;

WHEREAS, during the Opening of Bids on 02 December 2024 (Monday) at 10:00 AM, BAC-G opened the bid submission of two (2) bidders, Macrologic Diversified Technologies, Inc. and VastResult, Inc. , and was rated “*failed*” for both the eligibility and technical proposals due to NON-COMPLIANT technical component requirements, pursuant to Section 30.1 of the RIRR of RA 9184, to wit:

*“30.1. The BAC shall open the first bid envelopes in public to determine each bidder’s compliance with the documents required to be submitted for eligibility and for the technical requirements, as prescribed in this IRR. For this purpose, the BAC shall check the submitted documents of each bidder against a checklist of required documents to ascertain if they are all present, using a non-discretionary “pass/fail” criterion, as stated in the Instructions to Bidders. **If a bidder submits the required document, it shall be rated “passed” for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as “failed.”** Otherwise, the BAC shall rate the said first bid envelope as “passed.” (emphasis supplied)*

WHEREAS, BAC-G declared a failure of bidding for the **Procurement of Additional CCTV System and Preventive Maintenance of the Existing CCTV System in the Athletes Village (AV) at the National Government Administrative Center (NGAC) in New Clark City (NCC)** pursuant to Sections 35.1 of the 2016 RIRR of RA 9184, viz:

“35.1 The BAC shall declare the bidding a failure when:

xxx

- c) All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation;*

xxx”

NOW, THEREFORE, We, the Members of the Bids and Awards Committee for Goods, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

1. To declare a Failure of Bidding for the **Procurement of Additional CCTV System and Preventive Maintenance of the Existing CCTV System in the Athletes Village (AV) at the National Government Administrative Center (NGAC) in New Clark City (NCC)** in accordance with Section 35.1 of the 2016 RIRR of RA 9184; and
2. To direct the end-user, Information Communications and Technology Department (ICTD) to conduct a mandatory review and evaluation of the terms, conditions, and specifications of the Bidding Documents, including the cost estimates, and other requirements relative to this procurement, pursuant to Section 35.2 of the 2016 RIRR of RA 9184.
