 - e. Construction Safety and Health, Sanitation and Security Program;
 - f. PERT/CPM;
 - g. Contractor's All Risk Insurance; and
 - h. Personal Accident Insurance
- 2. Post a Performance Security denominated in Philippine Pesos in the form and in the amount stipulated in Section 39.2 of the 2016 RIRR of R.A. No. 9184, which shall be posted in favor of BCDA and which shall remain valid until the issuance of Certificate of Final Acceptance.
