



Relative thereto, may we seek your assistance and advice so that we could complete the closing of the abstract in the PhilGEPS website.



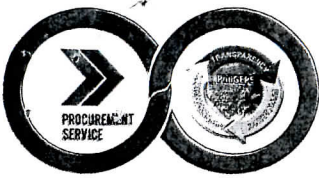
