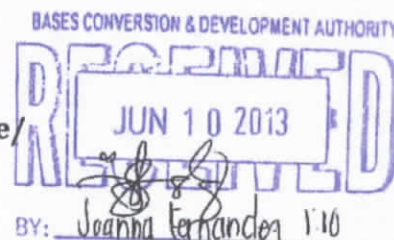



This refers to the required postings of government procurements in the Philippine Government Electronic Procurement System (PhilGEPS).

Recognizing the need to comply with the foregoing requirements, may we bring to your attention some problems being encountered by the Bases Conversion and Development Authority during our posting at the PhilGEPS website.

The Bids and Awards for Consulting Services (BAC-C) after conducting the shortlisting for BCDA Intranet Project and Poro Point Master Planning, updated the abstract in the PhilGEPS website. Unfortunately, during the updating, the system "hanged", which prompted the encoder to log out. As a result, the system does not already allow the encoder to complete the input of data such that the 2<sup>nd</sup> Bid Abstract cannot be created. Subsequently, we can no longer modify the data in the PhilGEPS website for the following projects:

1. Failed Bidding for the Procurement of Consulting Services for BCDA Intranet Project with Reference No. 2133526; and
2. Awarded Contract for the Procurement of Consulting Services for the Masterplanning of Poro Point Special Economic and Freeport Zone with Reference No. 2107551.

Thank you for your immediate action on this request.

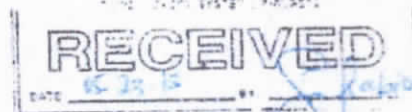
